UNANIMOUS CONSENT AGREEMENTS

S. 1082 (ORDER NO. 120)

1.—*Ordered*, That at 4:00 p.m. on Monday, May 7, 2007, upon the conclusion of Morning Business, the Senate resume consideration of S. 1082, a bill to amend the Federal Food, Drug, and Cosmetic Act to reauthorize and amend the prescription drug user fee provisions, and for other purposes; provided that there be 2 minutes for debate prior to a vote in relation to Amdt. No. 1010 offered by the Senator from Mississippi (Mr. Cochran); further, that upon the disposition of Amdt. No. 1010, that there be 2 minutes for debate prior to a vote in relation to Amdt. No. 990 as amended, if amended, offered by the Senator from North Dakota (Mr. Dorgan); provided further, that upon the disposition of Amdt. No. 990, as amended, if amended, there be 2 minutes for debate prior to a vote on the motion to invoke cloture on the substitute amendment, as modified and amended, to S. 1082, with all debate time equally divided and controlled in the usual form.

Ordered further, That there be no intervening amendments or action in order prior to the votes and that each vote after the first be 10 minutes each.

Ordered further, That first degree amendments be filed by 3:00 p.m. on Monday, May 7, 2007.

Ordered further, That relative to the cloture motions filed on S. 1082 and the substitute amendment to S. 1082, the mandatory quorum required under Rule XXII be waived. (*May 3, 2007.*)

H.R. 1495 (ORDER NO. 128)

2.—*Ordered*, That with respect to the motion to proceed to H.R. 1495, an act to provide for the conservation and development of water and related resources, to authorize the Secretary of the Army to construct various projects for improvements to rivers and harbors of the United States, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*May 3, 2007.*)
