UNANIMOUS CONSENT AGREEMENTS

STEM CELL BILLS

1.—*Ordered*, That at 9:30 a.m. on Wednesday, April 11, 2007, the Senate resume consideration, en bloc, of S. 5 (calendar No. 3), a bill to amend the Public Health Service Act to provide for human embryonic stem cell, and S. 30, a bill to intensify research to derive human pluripotent stem cell lines, there be 6½ hours of debate remaining, with the time divided as follows:

1½ hours each under the control of the Majority and Republican Leaders or their designees;

1½ hours each under the control of the Senator from Iowa (Mr. Harkin) and the Senator from Kansas (Mr. Brownback);

provided that the time until 12:30 p.m. be allocated as follows:

90 minutes under the control of the Senator from Iowa (Mr. Harkin) or his designee

45 minutes under the control of the Senator from Kansas (Mr. Brownback)

45 minutes under the control of the Senator from Minnesota (Mr. Coleman) or the Senator from Georgia (Mr. Isakson);

provided further, that the time from 2:15 to 5:15 be allocated in the above manner, and the time from 5:15 until 5:45 equally divided and controlled between the two Leaders or their designees, with the Majority Leader controlling the final 15 minutes.

Ordered further, That no amendments or motions be in order to either bill and that upon the use or yielding back of time, the bills be read a third time, en bloc, and that each bill be required to receive 60 votes in the affirmative to pass and that if S. 5 does not get 60 votes in the affirmative, it be returned to the Calendar and if S. 30 does not get 60 votes in the affirmative, it be placed on the Calendar; provided, that if either bill passes pursuant to the terms of this agreement, the motion to reconsider be considered made and laid on the table.

Ordered further, That at 5:45 p.m., without intervening action or debate, the Senate vote on passage of S. 5 to be followed by a vote on passage of S. 30 and that there be 2 minutes of debate prior to the second vote with the time equally divided between the two Leaders or their designees. (*Mar. 29, Apr. 10, 2007.*)

S. 372 (ORDER NO. 20)

2.—*Ordered*, That with respect to the cloture motion filed on the motion to proceed to S. 372, a bill to authorize appropriations for fiscal year 2007 for the intelligence and intelligence-related activities of the United States Government, the Intelligence Community Management Account, and the Central Intelligence Agency Retirement Disability System, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Apr. 10, 2007.*)
