UNANIMOUS CONSENT AGREEMENTS

H.R. 3074 (ORDER NO. 286)

1.—*Ordered*, That at 9:00 a.m. on Wednesday, September 12, 2007, the Senate resume consideration of H.R. 3074, an act making appropriations for the Departments of Transportation, and Housing and Urban Development, and that the following be the only amendments in order, other than a managers' amendment which has been cleared by the managers and leaders, and that no second degree amendments be in order to any amendment, and that the amendments be voted on in the following order:

DeMint Amendment relating to Davis-Bacon;

Coburn amendments 2812–2814, en bloc.

Ordered further, That when the Senate resumes consideration of the bill on Wednesday, September 12, there be 20 minutes of debate with respect to the DeMint amendment, with the time equally divided and controlled between Senators DeMint and Kennedy, or their designees; and that no points of order be waived by this agreement.

Ordered further, That there be 2 minutes for debate prior to each vote, with that time equally divided and controlled in the usual form; that after the first vote in the sequence, the remaining votes be limited to 10 minutes; that upon disposition of the listed amendments, the bill be read a third time and the Senate proceed to vote on passage of the bill. (*Sept. 11, 2007.*)
