UNANIMOUS CONSENT AGREEMENT**H.R. 6 (ORDER NO. 9)**

Ordered, That on Wednesday, June 13, 2007, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 6, an act to reduce our Nation's dependency on foreign oil by investing in clean, renewable, and alternative energy resources, promoting new emerging energy technologies, developing greater efficiency, and creating a Strategic Energy Efficiency and Renewables Reserve to invest in alternative energy, and for other purposes; that the time until 11:45 a.m., be for debate with respect to Amdt. No. 1505, offered by the Senator from Oklahoma (Mr. Inhofe), with the time equally divided between the Senator from Oklahoma (Mr. Inhofe) and the Senator from California (Mrs. Boxer), or their designees, and that upon the use or yielding back of time, the Senate proceed to vote in relation to the amendment, without further intervening action or debate, and that no amendment be in order to the amendment prior to the vote.
