UNANIMOUS CONSENT AGREEMENTS

S. 372 (ORDER NO. 20)

1.—*Ordered*, That at 3:00 p.m. on Monday, April 16, 2007, the Senate resume consideration of S. 372, a bill to authorize appropriations for fiscal year 2007 for the intelligence and intelligence-related activities of the United States Government, the Intelligence Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes, and that Senator Rockefeller be recognized at that time to offer a managers' amendment on behalf of himself and Senator Bond.

Ordered further, That at 5:30 p.m. on Monday, April 16, 2007, the Senate proceed to a vote on the motion to invoke cloture on the bill.

Ordered further, That first-degree amendments be filed by 2:30 p.m. on Monday, April 16, 2007.

Ordered further, That the mandatory quorum call under Rule XXII be waived. (*Apr. 12, 2007.*)

S. 3

2.—*Ordered*, That on Monday, April 16, 2007, it be in order for the Majority Leader to move to proceed to S. 3, to amend part D of title XVIII of the Social Security Act to provide for fair prescription drug prices for Medicare beneficiaries, if reported by the Committee on Finance between 12 noon and 2 p.m. on Friday, April 13, 2007.

Ordered further, That if the Committee on Finance does not report S. 3 on Friday, April 13, 2007, it be in order on Monday, April 16, 2007, for the Majority Leader to introduce a bill dealing with the same subject, and that it be in order for the Majority Leader to move to proceed to that bill on Monday, April 16, 2007. (*Apr. 12, 2007.*)
