UNANIMOUS CONSENT AGREEMENTS

S. 372 (ORDER NO. 20)

1.—*Ordered*, That on Tuesday, April 17, 2007, upon the conclusion of Morning Business, the Senate resume consideration of S. 372, a bill to authorize appropriations for fiscal year 2007 for the intelligence and intelligence-related activities of the United States Government, the Intelligence Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes.

(*Apr. 16, 2007.*)

3.—*Ordered*, That with respect to the cloture motion filed on the motion to proceed to S. 378, a bill to amend title 18, United States Code, to protect judges, prosecutors, witnesses, victims, and their family members, and for other purposes, the mandatory quorum call under Rule XXII be waived.
