UNANIMOUS CONSENT AGREEMENTS

H.R. 3043 (ORDER NO. 280)

1.—*Ordered*, That at 10:00 a.m., on Tuesday, October 23, 2007, the Senate resume consideration of H.R. 3043, an act making appropriations for the Departments of Labor, Health and Human Services, and Education, and related agencies for the fiscal year ending September 30, 2008, and for other purposes.

Ordered further, That the Senator from Wyoming (Mr. Enzi) be recognized to call up Amdt. No. 3437, and there be 30 minutes of debate, equally divided and controlled in the usual form, and that upon the use or yielding back of time, the amendment be temporarily set aside.

Ordered further, That the Senator from South Carolina (Mr. DeMint) then be recognized to call up Amdt. No. 3387, and that there be 20 minutes of debate, equally divided and controlled in the usual form, and that upon the use or yielding back of time, the amendment be temporarily set aside.

Ordered further, That the Senate then resume consideration of Amdt. No. 3365, offered by the Senator from Kansas (Mr. Roberts), and that there be 10 minutes of debate, equally divided and controlled in the usual form.

Ordered further, That upon the use or yielding back of time on Amdt. No. 3365, the Senate resume consideration of Amdt. No. 3358, offered by the Senator from Oklahoma (Mr. Coburn), and there be 20 minutes of debate equally divided and controlled in the usual form, prior to a vote.

Ordered further, That upon the use or yielding back of time on Amdt. No. 3358, the Senate return to Amdt. No. 3437 and vote in relation to the amendment; and that upon disposition of Amdt. No. 3437, the Senate return to Amdt. No. 3387, and vote in relation to the amendment; provided further that upon disposition of Amdt. No. 3387, the Senate proceed to vote in relation to Amdt. No. 3365, and that upon the disposition of Amdt. No. 3365, the Senate proceed to vote in relation to Amdt. No. 3358; further that there be two minutes of debate prior to each vote, equally divided and controlled and that no amendments be in order to any of the above amendments prior to the vote; and that after the first vote, the vote time be limited to 10 minutes. (*Oct. 22, 2007.*)

S. 2205 (ORDER NO. 431)

2.—*Ordered*, That with respect to the cloture motion filed on the motion to proceed to S. 2205, a bill to authorize the cancellation of removal and adjustment of status of certain alien students who are long-term United States residents and who entered the United States as children, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 22, 2007.*)

3.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.
