UNANIMOUS CONSENT AGREEMENT

H.R. 1591 (ORDER NO. 84)

Ordered, That at 10:00 a.m. on Wednesday, March 28, 2007, the Senate resume consideration of H.R. 1591, an Act making emergency supplemental appropriations for the fiscal year ending September 30, 2007, and for other purposes.

Ordered further, That there be 30 minutes for concurrent debate of Amdt. No. 709 offered by the Senator from Oregon (Mr. Wyden) and Amdt. No. 716 offered by the Senator from North Carolina (Mr. Burr) equally divided and controlled by the Senator from Oregon and the Senator from North Carolina, or their designees; provided that Amdt. No. 716 be modified to be a first degree amendment; provided further that no amendment be in order to either amendment.

Ordered further, That there then be 30 minutes of debate equally divided between the two Leaders or their designees on the motion to invoke cloture on the measure.

Ordered further, That upon the use or yielding back of time, the Senate proceed to vote in relation to Amdt. No. 709, to be followed by a vote in relation to Amdt. No. 716, to be followed by a vote on the motion to invoke cloture; provided that there be 2 minutes of debate, equally divided, prior to each vote.

Ordered further, That with respect to the cloture motion filed on H.R. 1591, the mandatory quorum call under Rule XXII be waived.

Ordered further, That Senators have until 10:30 a.m. on Wednesday, March 28, 2007, to file second degree amendments.

Ordered further, That on Wednesday, March 28, 2007, it be in order for the Senator from Nebraska (Mr. Hagel) to call up Amdt. No. 707 and that there be 90 minutes of debate on the amendment under the control of the Senator from Nebraska and that upon the use or yielding back of time, the amendment be withdrawn.
