EIGHT COLUMBIA RESIDENTS ARRESTED, TWELVE OTHERS WANTED

Columbia, South Carolina ---- United States Attorney REGINALD I. LLOYD stated today that eight Columbia residents have been arrested and twelve others are wanted in connection with federal drug conspiracy charges.

A federal grand jury returned an Indictment which charged these individuals with conspiring to traffic 5 kilograms or more of cocaine and 50 grams or more "crack" cocaine, in violation of Title 21, United States Code, Section 846.

REGINALD I. LLOYD stated that these defendants face up to life in prison and a fine of \$4 million.

Mr. Lloyd stated that the case was investigated by the Columbia Violent Gang Task Force, which includes agents of the Federal Bureau of Investigation (FBI), the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF), the Columbia Police Department, the Richland County Sheriff's Office, and South Carolina Law Enforcement Division (SLED); and that he has assigned the case to Assistant United States Attorney Jane B. Taylor of the Columbia office for prosecution.

The United States Attorney stated that all charges in this Indictment are merely accusations and that all defendants are presumed innocent until and unless proven guilty.
