Puppy Foster Application

Thank you for your interest in fostering a TSA puppy. The decision to foster a pup is one that must be taken seriously. In order to ensure the safety of the pups there are a few requirements all foster families must meet-

- 1. You must live in San Antonio/Austin, Texas or surrounding communities.
- 2. You must have a secure fenced yard.
- 3. You must live in a residence that permits large breed dogs.
- 4. There cannot be more than two dogs in the home already.
- 5. You must show proof of your pet's current vaccinations.
- 6. You must have a vehicle to safely transport the TSA puppy.

Once we receive and review your application you will be notified by phone or email to set up a home interview. If all of the requirements are met, you will be asked to attend an orientation before receiving a pup. If you are not eligible to foster a puppy in your home, there are options to volunteer at our facility as well. For additional information about the program please feel free to contact us.
