## Jeff Wickliffe, PhD.

Jeff Wickliffe is an environmental toxicologist and assistant professor in the Department of Preventive Medicine and Community Health at the University of Texas Medical Branch in Galveston, Texas. His interests are varied and include laboratory studies designed to examine the mechanisms by which environmental and occupational chemicals cause damage to cells and tissues, assessing exposure to such chemicals in laboratory studies and human populations, and genetic and environmental interactions that serve to explain why some individuals are uniquely susceptible to disease caused by chemical exposure. He has extensively studied the effects of environmental radiation and chemical pollutants on rodents that serve as surrogates for ecological effects and human populations that are risk. He has also studied genetic effects in workers exposed to chemicals as part of their occupational history. His research is aimed at understanding the basis for chemical effects in human populations and individual susceptibility to such effects within human populations. He is also interested in understanding such effects in animal populations that live in compromised habitats. He instructs courses in basic science including toxicology and molecular toxicology. He has also instructed an undergraduate philosophy course in environmental ethics. Another major interest area, centers around environmental justice and disparities in exposure. The confluence between chemical effects in human populations, individual susceptibility, and environmental injustice serves to focus our efforts in the areas where they are most needed. Concepts of risk assessment, risk perception, and individual risk and the effects applying risk concepts are also of major interest.
