DECISION AND ORDER OF DISMISSAL

The parties to this action have submitted the Stipulation and Order which is attached and incorporated in this Order. The Grant Officer has revised his Final Determination, indicating that the sum of \$32,977.00 is presently due to the U.S. Department of Labor, Employment and Training Administration. Arizona Department of Economic Security agrees to pay \$32,977.00 to the U.S. Department of Labor within thirty days of signing the Stipulation and Order. The U.S. Department of Labor waives interest on the sum of \$32,977.00, unless these monies are not paid within the period specified.

The parties agree that an Order disposing of this matter shall be based solely on the Complaint and the settlement agreement between the parties.

Finally, Arizona Department of Economic Security withdraws its request for a hearing.

Order

1. Arizona Department of Economic Security shall pay \$32,977.00 to the U.S. Department of Labor, Employment and Training Administration.

2. Case No. 85-WPA-2, In the Matter of Arizona Department of Economic Security, is dismissed.

THEREFORE, the parties hereby stipulate and agree as  
follows:

1. Subsequent to the audit referred to above, an  
additional audit was conducted which recommended that the


