

## ***SUBSTANCE ABUSE PROFESSIONAL (SAP) TRAINING and EXAMINATION***

The Department of Transportation regulation - 49 CFR Part 40 - requires Substance Abuse Professionals to successfully complete training and an examination. There are a number of organizations currently offering the SAP training and/or examinations. The following list contains sources for one or both required components.
