Together with our managing partner the Tennessee Wildlilfe Resource Agency, we will work to meet this mandate through the development of management programs to preserve the river in a free-flowing condition, protect water qualitly, wildlife resources and the primitive character of the river. The Park's resource education and interpretive programs will be aimmed at building partnerships among landowners, river users, local community leaders, volunteers, and environmental organizations to improve understanding of river values and processes as well as deepen awareness, acceptance and appreciation of river conservation.

Protect the outstandingly remarkable values of the Obed Wild and Scenic River by rehabilitating the recently acquired sandstone quarry, located immediately upslope of Clear Creek, a major tributary to the Obed River and federally designated habitat for the spotfin chub. These remarkable scenic, recreational, geological and fish and wildlife values, as determined by the Obed River Task Force, qualify the park for inclusion in the National Wild and Scenic River System.

Partner with local non-profit organizations to acquire, protect and restore lands or aquatic habitats that will further water quality goals within the park. Grant opportunities both within and outside the Service will be explored, focusing on land acquisitions that will increase federal ownership within the park's congressionally authorized boundary. Organizations such as the Tennessee Citizens for Wilderness Planning and local watershed protection organizations will be kept abreast of potential purchases, funding or restoration opportunities. Funding will be sought through the Service's project management information system and grant organizations such as the National Fish and Wildlife Foundation.
