

SEER Cancer Incidence and US Death Rates, 2002-2006 By Cancer Site and Race



SEER Incidence 1997-2006 Males by Race/Ethnicity



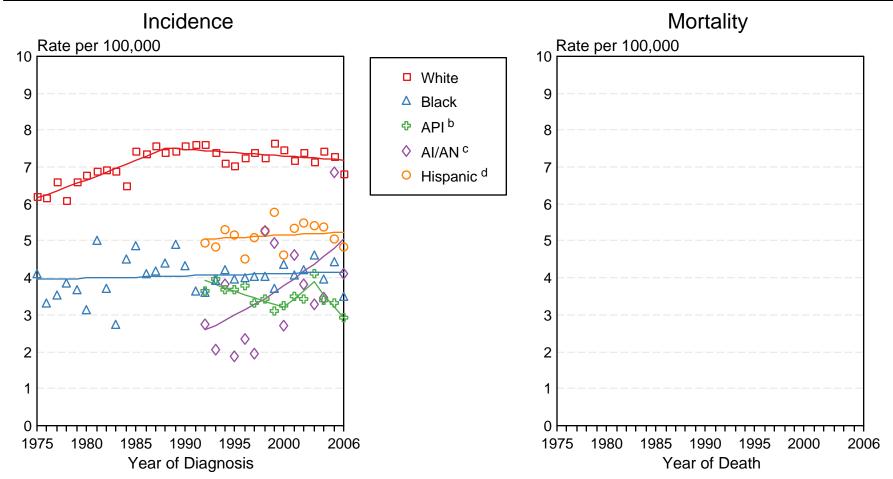























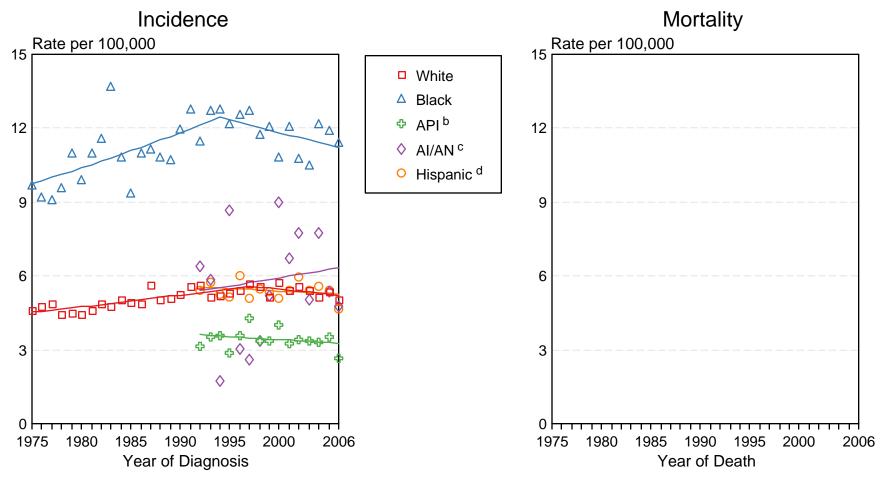






















