# Results of the e-vote on VeriSign Cross Certification at Rudimentary, Basic, Medium and Medium Hardware—Terry McBride

Mr. McBride reported that 14 agencies voted to approve the VeriSign Cross-Certification at Rudimentary, Basic, Medium and Medium Hardware, or 93.3%% where a 75% majority vote was required. Commerce did not vote.

#### Agenda Item 5

#### DoD Public Key (PK) Enabling Applications —Camie Webster

Camie Webster (DISA) described efforts to operationalize PKI at DoD. NSA and DISA are the DoD PKI PMO. JITC does the testing. DoD uses OCSP or products from CoreStreet and Tumbleweed. Applications provided by this team are code signed.

Camie Webster of DISA gave a presentation on various DoD Relying Party services. Examples include:

- A Root Tool which periodically downloads DoD trusted roots and CRLs
- A PDVal tool for testing interoperability of roots
- JITC tests interoperability

• Provide sample code to admins

Judy Spencer commented that these were interesting and would like to see them shared and used where appropriate. Cheryl Jenkins mentioned that these tools/services are the kind of thing the FPKI MA TAG would look at. Charles Froehlich asked if he could get the DoD internal URL where civilian roots are posted in order to provide that to DoD callers who have requested information. DoD said that they would get back to him, but it should not be a problem.

The PowerPoint slides will be e-mailed to the FPKIPA listserv, along with POC information. (Done)

Judith Spencer will set up a small group to review the DoD documentation to make it less DoDcentric, and will make it available to the community at large via a GSA collaboration site: CORE.gov as a "lessons learned." She also plans to set up a test environment for the Civilian agencies.

#### Agenda Item 6

# FPKI Certificate Policy Working Group (CPWG) Report—Charles Froehlich, Judith Spencer

a. Discuss/Vote on Common Policy CP Change Proposal: 2009-01—Change the nextUpdate Period for Legacy PKIs

Last night, DOC (NIST) voted against this change proposal in an email from Tim Polk to Judith Spencer. Tim Polk thought 180 hours after issuance time was too much. Although Mr. Polk is still open to extending the *nextUpdate* time in the CRL, Debbie Mitchell said that DoD needs seven days (168 hours), minimum. Treasury had some concerns about the liability issue.

DoD expressed concern because they had a meeting with NIST personnel to discuss and understood them to be on board. The quorum decided to postpone vote until the CPWG could meet with NIST and include Tim Polk. Debbie Mitchell requested an e-vote follow that meeting.

This change proposal was rescinded and will be taken back to the CPWG meeting of January 22, 2009 and NIST participation will be requested. (Done--The meeting was held at NIST to accommodate Mr. Polk's schedule).

 Discuss/Vote on FBCA CP Change Proposal: 2009-02—In-Person Antecedent for Medium Hardware

The CPWG discussed in-person antecedent and has formed a committee to formulate policy for antecedent. Debbie Mitchell stated that SP 800-63 doesn't allow it and the CP should match 800-63. Judy Spencer stated that SP 800-63-1 is in comment period. She also noted that NIST makes an exception for financial institutions (FIs) (if the user has a relationship with a FI that can be used to verify). Judy stated that she would talk to them and that they should take a broader view

than just FIs. SP 800-63 also states that FBCA Medium HW qualifies for level 4 and FBCA Medium HW allows for third-party antecedent.

This item was tabled because SAFE has a major issue with this change proposal. SAFE relies heavily on in-person antecedent. It will be discussed again at the 22 January 2009 CPWG meeting (Done).

c. Discuss/Vote on FBCA CP Change Proposal: Archiving Requirements

Charles Froehlich said that a Change Proposal to remove the requirement to Backup Archives is forthcoming. He indicated that it was an oversight that the Change Proposal was not on the agenda, and requested that an e-vote be sent out. The PA agreed that the Change Proposal could be sent out for e-vote.

Due to Ms. Fincher's absence (due to the death of her mother), the e-vote did not occur. This item will be voted on at the 10 February 2009 FPKIPA meeting.

d. Discuss State of Illinois Mapping Report-at Basic, Medium, Medium Hardware

The CPWG reported that there was a problem discovered with Illinois RA hardware module not meeting FIPS 140-2. Illinois is currently upgrading. The CPWG will continue the mapping process and when the upgrade is made, final mapping will be conducted. In the meantime, the CPWG recommends renewing the current cross-certificate at BASIC only.

The FPKIPA had no objection to this and will direct the FPKIMA to issue a crosscertificate to Illinois at BASIC only.

e. Discuss/Vote on DoD ECA Mapping Report—at Medium, Medium Hardware

The CPWG reported that ECA was successfully mapped at Medium and Medium HW, pending an ECA Change Proposal that is in process. The FPKIPA received a memo from the DoD's Shawn O'Brien indicating that the ECA will adopt the change. The PA voted to approve with 100% of those voting.

The CPWG recommends cross-certification with DoD ECA at Medium and Medium Hardware. DoD has accepted our comments and have incorporated our requested changes. We received the latest draft of the DoD ECA CP last night, according to Charles Froehlich.

#### FPKI Management Authority (FPKI MA) Report—Cheryl Jenkins, Wendy Brown

Wendy Brown reported that interoperability testing with Verizon Business Systems was completed in November 2008. She also gave the status that Wells Fargo certificates had been issued, but not posted by WF. Cheryl Jenkins said that she is forming a Technical Advisory Group (TAG) to provide strategic advice to the MA. The members of this group are recognized in the PKI world: The first meeting will be in February. Members are Bill Russell, Chris Louden, Santosh Chokhani and Yuri Dzambasow.

#### Agenda Item 8

#### Formation of the ISIMC—Judith Spencer

Judy Spencer discussed changes in the CIO Council structure The CIO Council has stood up an Information Security and Identity Management Committee (ISIMC) and under it is the Identity, Credential and Access Management (ICAM) sub-committee. It is likely that the FPKIPA will report to the ICAM. Rob Kerry from Justice will chair the ISIMC.

Under this committee are four sub-committees: one deals with cyber security and three with site security. The Identity, Credential and Access Management (ICAM) sub committee will replace the FICC.

Judith Spencer sent out a nomination form for the FICC agencies to fill out so they can continue in the identity arena. She did not send one out to the FPKIPA because she thinks the FPKIPA will continue to exist under the ICAM as a separate, sovereign group.

Carol Bales is lobbying for Judith Spencer to be Chair of the ICAM SC. All this is still in the organizational phase.
