 - A. Approaching PKI related ERM

In view of the interest in the ERM issues surrounding PKI, a plan of approach is being worked on by Mark Giguere and Art Purcell for the Wednesday Steering Committee Meeting.

- B. CP Review re States-
 - 1. "What is the Liability?"

The group engaged in a lively debate centered regarding the question of "what is the liability?" for the Federal Bridge and for other Bridges or organizations when they cross-certify with the Federal Bridge. One suggestion was to analogize to the credit card and the division of risk of loss in the relationship between consumer, merchant and credit card company that is largely a matter of contract within some limits set by law. Another suggestion was to analyze the problem under tort law. It was generally agreed that we are attempting to define trust relationships. The possibility of enabling legislation, regulations or rules was also raised. In any case, representations and warranties made to the all parties must be examined carefully.

Part of the discussion focused on the difference in monetary liability and risk in a fraudulent transaction and less quantifiable risks from exposure of SSA data, medical records, etc.
