

**Federal PKI Steering Committee Meeting
February 13, 2002**

EDUCAUSE – NIH PKI Interoperability Project:

Mark Luker (VP of EDUCAUSE) and Peter Alterman (NIH) gave the Steering Committee (SC) members a presentation on this project that consisted of several higher education institutions successfully sending electronic grant forms signed with institutional digital signatures to the NIH. EDUCAUSE linked the Higher Education Bridge to the prototype Federal Bridge. Once the two bridges were cross certified, administrators at the NIH could verify and validate the digital signatures affixed to electronic documents sent by the three universities. Entrust, RSA Security Inc, and IPlanet (Netscape) CA products were used. E-Lock Pro Signer software (which is CAM enabled) was used on the users desktop to validate the digital signatures. The CAM and an addition, DAVE (Discovery And Validation Engine) were modified to make the paths accessible. An X.500 directory and LDAP directories communicated with each other. Mitretek Systems and Digital Signature Trust provided engineering and programming support. EDUCAUSE is a nonprofit association for information technology in higher education.

Federal Bridge Certification Authority (FBCA):

Microsoft's beta three version of its "Dot Net" CA product has successfully demonstrated the ability to meet the requirements for interoperability within the FBCA membrane. Microsoft is planning for its "Dot Net" CA product to be released in the 3rd quarter of this year.

We need to start analyzing the policy issues associated with the interoperability of two bridges (FBCA and the Higher Education Bridge CA).

NASA has successfully demonstrated cross-certification and technical interoperability with the prototype FBCA.

NASA, NFC, and DoD submitted to the Federal PKI Policy Authority their draft Application for Interoperability with the FBCA. The State of Illinois paperwork should be submitted in the mid-March timeframe. The Government of Canada paperwork should also be submitted this year.

We're entering into a pilot with the NIST and SingleSignOn.Net to issue SC members' digital certificates to access secure web pages on the SC web site. Representatives from SingleSignOn.Net will brief the SC members at the meeting in March.

Electronic Records Management (ERM):

Any government employee interested in participating with the ERM working group should attend either the March 18th (1pm to 4pm) or March 20th (9am to 12pm or 1pm to 4pm) meeting. The purpose of the ERM working group is to determine what additional areas of coverage are needed to determine ERM requirements for PKI implementations.

Technical Working Group (TWG):

Bill Burr currently chairs the TWG. Bill suggested to Judy Spencer that the TWG needs new management. Instead of merging the Business Working Group and the TWG, Judy would like a volunteer from the SC to manage the TWG. In the near future, Mitretek Systems will brief the TWG on DAVE.

E-Authentication:

There is going to be an E-Authentication meeting on February 14th, at 12pm in the Architects Building, Board Room. All SC members are welcome to attend. There are now officially 24 E-Gov initiatives.

Health Care Working Group (HCWG):

As an action item from the HCWG Conference, a WWW page is being established with links to other WWW pages that contain Certificate Policies and other PKI-related documentation. This will be done for Federal Government sources and later may be expanded to include others. If an agency has such documents currently posted on their WWW site, it is requested that they e-mail Brant Petrick the URL so we can link to these governmental documents from the HCWG web page. The Drug Enforcement Administration (DEA) is planning to implement a national PKI for all doctors that prescribe controlled substances (drugs such as narcotics) and a pharmaceutical national system for issuing controlled substances. The DEA wants to cross-certify with the FBCA. The next HCWG meeting is scheduled for February 26th at the HHS/CMS in Baltimore, MD.
