SUPERVISORY/MANAGERIAL: No AREA OF CONSIDERATION: IHS WIDE

DESCRIPTION OF ASSIGNMENT: Incumbent enforces hospital parking rules and regulations, researches hospital database for information of the name of those in violation of parking privileges. Forwards documentation of violations to Security Supervisor for follow-up action by supervisor of those who violate parking regulations. Responds to ambulance and helipad delivery/transporting away of patients consistent with emergency management requirements; coordinates the involvement of other assigned hospital staff. Upon request, escorts hospital personnel, patients, or visitors to and from parking areas. Upon request, assists Nursing personnel in restricting disturbed or rambunctious patients in necessary inpatient areas and or emergency areas, or wherever necessary. Uses daily sign in Journal making notations of unusual circumstances out of the ordinary. Serve on the inhouse fire response team and is responsible for performing procedures leading up to and/or setting up the decontamination tent during emergency management events (actual incidents and drills). Coordinates the back-up from the Housekeeping staff on duty during emergency security issues, especially during the weekends and after hours whenever there is a single guard on duty. In response to direct instructions from the Nurse Supervisor, transports emergency order of detention (EOD) patients to outside facilities. In response to direct instructions from the Laboratory staff, transports lab specimens to Comanche County Memorial Hospital and health care facilities.

<u>INDIAN PREFERENCE:</u> In the filling of this position by appointment, promotion, transfer, reassignment, reinstatement, or any other personnel action, we are required by law to give absolute preference in selection to qualified Indian preference candidates. Eligibility will be determined from current Indian Health Service Policy. (See APPLICATIONS FORMS for information on how to claim Indian Preference)

EQUAL EMPLOYMENT: Except for Indian Preference, consideration will be made without regard to any non-merit factor such as race, color, religion, sex, sexual orientation, national origin, politics, disabilities, marital status, age, or membership or non-membership in any employee organization.

REASONABLE ACCOMMODATIONS: Reasonable accommodation is provided to applicants with disabilities, except when so doing would impose an undue hardship on the Indian Health Service. CONDITIONS OF EMPLOYMENT:

- 1. One- Full-Time, Time –Limited Appointment NTE 13 Months. Agency has option of extending Time-Limited appointments for up to a maximum of four years. Position may become permanent.
- 2. IMMUNIZATION REQUIREMENT- In accordance with the IHS Employee Immunization policy, selectee will be required to be immunized against measles and rubella by providing documentation/proof of immunity to measles and rubella prior to entrance on duty. QUALIFICATION REQUIREMENTS

Excepted Service Indian Preference applicants, both those who apply under the Excepted Service Examining Plan (ESEP) and those who are currently on permanent appointment in Indian Health Service, will be rated in accordance with the Indian Health Service Excepted Service Qualification Standards (if established). Normally, Competitive Service Indian Preference applicants will be rated in accordance with the Office of Personnel Management (OPM) Qualification Standards Handbook, however, these applicants who wish to be considered under the ESEP will be rated separately under the IHS Excepted Service Qualification Standards, or under both standards, if requested. All Non-Indian Preference applicants will be considered under OPM Qualification Standards. The two Qualification Standards are essentially the same, however, any Time-In-Grade requirements will not apply to ESEP applicants. Your description of work experience, level of responsibility, and accomplishments will be used to determine that you meet these requirements.

<u>LEGAL AND REGULATORY REQUIREMENTS:</u> Candidates must meet all requirements cited in the following "qualifications required section" within 30 days after the closing date of the vacancy announcement.

QUALIFICATIONS REQUIRED:

GS-4: 6 months of general experience and 6 months of specialized experience.

<u>General Experience</u>: Experience such as administrative, technical, clerical, military, or other work that involved following written procedures, rules or regulations in contacts with coworkers, supervisors, or members of the public to provide a service, respond to inquiries, or obtain information.

<u>Specialized Experience</u>: Experience such as work with a Federal, State, municipal, local or private protective organization that involved the protection of property against such hazards as fire, theft, damage, accident or trespass; or maintaining order and protecting life. Such experience must have provided a knowledge of protective systems and techniques. Acceptable experience includes service in the Armed Service or Coast Guard that involved the performance of guard duties on a regular or intermittent basis. For Security Guard positions in a hospital setting, experience as a psychiatric nursing assistant or a similar position safeguarding patients is qualifying.

INVESTIGATION OF FITNESS

A character investigation may be conducted on applicants selected for employment. The purpose of such an investigation is to secure evidence of the candidate's honesty, integrity, general character, and loyalty to the U. S. Government. Such investigations will be conducted under the security requirements of the hiring agency.

The duties of these positions require moderate to arduous physical exertion and/or duties of a hazardous nature.
