The Committee on the Judiciary had referred to it 1,003 bills and resolutions during the 102nd Congress. This represents 16% of the 6,212 bills and resolutions introduced in the U.S. House of Representatives for that Congress. Of this number, 877 were public bills and resolutions, and 126 were private bills and resolutions. A total of 57 which received consideration by the Committee were enacted into public law; and a total of 20 measures considered by the Committee were enacted into private law.
