The Committee on the Judiciary had referred to it 1,021 bills and resolutions during the 103rd Congress. This represents 19% of the 5,310 bills and resolutions introduced in the U.S. House of Representatives for that Congress. Of this number, 934 were public bills and resolutions, and 87 were private bills and resolutions. A total of 49 which received consideration by the Committee were enacted into public law; and a total of 7 measures considered by the Committee were enacted into private law.
