UNANIMOUS CONSENT AGREEMENTS

H.R. 6304 (ORDER NO. 827)

1.—*Ordered*, That at 9:30 a.m. on Wednesday, July 9, 2008, the Senate resume consideration of H.R. 6304, an act to amend the Foreign Intelligence Surveillance Act of 1978 to establish a procedure for authorizing certain acquisitions of foreign intelligence, and for other purposes, and that there then be 60 minutes of debate equally divided and controlled between the Leaders or their designees, and of the time controlled by the Majority Leader, 10 minutes shall be under the control of the Senator from Vermont (Mr. Leahy) and 10 minutes shall be under the control of the Senator from New Mexico (Mr. Bingaman); provided, that there be an additional 30 minutes under the control of the Senator from Wisconsin (Mr. Feingold), 15 minutes under the control of the Senator from Connecticut (Mr. Dodd), and 10 minutes under the control of the Senator from Pennsylvania (Mr. Specter); provided further, that upon the use or yielding back of time, the Senate proceed to vote in relation to the pending amendments; further, that upon disposition of the amendments, the Senate then vote on the motion to invoke cloture on the bill, and that if cloture is invoked, then all post-cloture time be yielded back, and without further intervening action or debate, the Senate proceed to vote on passage of the bill, as amended, if amended.

Ordered further, That there be two minutes of debate, equally divided and controlled in the usual form prior to each vote; provided, that after the first vote in a sequence, succeeding votes be limited to 10 minutes each.

Ordered further, That the only amendments in order be the following:

An amendment offered by the Senator from Connecticut (Mr. Dodd), the Senator from Wisconsin (Mr. Feingold) and the Senator from Vermont (Mr. Leahy) to strike immunity,

A relevant amendment offered by the Senator from Pennsylvania (Mr. Specter), and

An amendment offered by the Senator from New Mexico (Mr. Bingaman) regarding staying court cases against telecom companies.

Ordered further, That the Specter and Bingaman amendments be subject to an affirmative 60-vote threshold, and that if they do not achieve that threshold, they be withdrawn; if they achieve that threshold, they be agreed to and the motions to reconsider be considered made and laid upon the table.

Ordered further, That it be in order to file the cloture motion on the bill at any time prior to the cloture vote, with the mandatory quorum waived, notwithstanding Rule XXII, if applicable, and if applicable, post cloture time be charged during this agreement. (*June 26, July 7, 8, 2008.*)

HOUSE MESSAGE TO ACCOMPANY H.R. 3221

2.—*Ordered*, That with respect to the motion to disagree to the amendments of the House adding a new title and inserting a new section to the amendment of the Senate to H.R. 3221, an act to provide needed housing reform and for other purposes, the mandatory quorum under Rule XXII be waived.

Ordered further, That no further motions to refer be in order during the pendency of the House message. (*June 19, 26, 27, July 8, 2008.*)

H.R. 6331 (ORDER NO. 836)

3.—*Ordered*, That if cloture is invoked on the motion to proceed to H.R. 6331, an act to amend titles XVIII and XIX of the Social Security Act to extend expiring provisions under the Medicare Program, to improve beneficiary access to preventive and mental health services, to enhance low-income benefit programs, and to maintain access to care in rural areas, including pharmacy access, and for other purposes, all post-cloture time be yielded back, the motion to proceed be agreed to, and the Senate proceed to the consideration of the bill, that the bill be read a third time, passed, and the motion to reconsider be considered made and laid upon the table, without further intervening action or debate.

Ordered further, That if cloture is not invoked, then the motion to proceed be withdrawn and the bill returned to the calendar. (*June 26, 2008.*)

S. 1974

4.—*Ordered*, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (*Mar. 31, 2008.*)

VETO MESSAGE ON S. 5

5.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (*June 20, 2007.*)

H.R. 3997

6.—*Ordered*, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance. (*Dec. 12, 19, 2007.*)
