ALS: Acquisition Learning Seminars By Otis Langford

On February 6, 2008, FAI held an Acquisition Learning Seminar (ALS) titled "It's Easy Being Green" at the GSA HQ Auditorium, 1800 F Street NW, Washington, D.C.

Presenters for this ALS were Dana Arnold, Office of the Federal Environmental Executive (OFEE); Shana Love, U.S. Department of Agriculture (USDA); and Holly Elwood, U.S. Environmental Protection Agency (EPA). Topics for presentation and discussion included:

- the FAR changes released in November 2007 on Green Purchasing;
- the Electronic Product Environmental Assessment Tool, EPEAT™, an environmental procurement tool designed to help institutional purchasers compare and select desktop computers, laptops and monitors based on their environmental attributes; and
- BIO Preferred (SM) commercial or industrial products (other than food or feed) composed wholly or in significant part of biological products—including renewable agricultural (plant, animal, and marine) or forestry materials.

The session had over 150 participants and FAI is making arrangements to capture ALS information in a format that will allow for future posting as a continuous learning module so professionals all around the country can participate in the learning seminars and gain continuous learning points.


How can I register?


The contracts for most FAC-C classes have been awarded! However, the Contracting courses CON 120, CON 215, and CON 218 have not been awarded.

Course-Related Policies

Eligibility and Prerequisites. All FAI courses are open to members of the federal acquisition community with executive agency personnel in civilian agencies as the first priority. Certain courses may have additional eligibility criteria, based on career specialty or prerequisite knowledge. Use the FAI course description listing on the FAI website to inquire about eligibility.

Supervisor's Approval. Supervisors are encouraged to promote the professional development of their employees by recommending enrollment in training courses. When you register in the FAITAS system, your supervisor must electronically approve your application. However, your supervisor's approval is not the only approval authority; the FAI Registrar also reviews your application for eligibility.

Enrollment Priorities & Class Size. Enrollment priorities are established for the courses and can be found on the FAI website. Each class size is fixed at a maximum ceiling. Once met, the remaining applicants are placed on a waiting list.

Waiting Lists. If a course class is full or if you do not have priority standing for early enrollment when you apply, you will be placed on the class waiting list. If you remain on the course waiting list and do not get a seat in that class, you must apply for another class. You will not be automatically enrolled in a future class.

Cancellations. If you must cancel your application or enrollment in a course, please do so as early as possible so the next person on the waiting list can be enrolled in the course. If you do not cancel your registration, your attendance will be recorded as a "no-show." You must use the FAITAS system for cancellations. It is also important that you notify your supervisor of your cancellation. Students can not substitute for another person in a class.

Cost. All FAI-sponsored courses described on the FAI website are provided through the Acquisition Workforce Training Fund and there is no cost for tuition.
