Vision Statement

As the newest National Park in the system, we are building on the 75-yr history of the Great Sand Dunes as a National Monument and our goal is to become one of the best national parks for working and for visiting. The park will increase quality research/science by engaging researchers from a variety of sources. We will provide adequate, appropriate, educational and safe visitor experiences. The park will be a positive and proactive partner with neighbors. Park management will be transparent and accountable. The centennial decade presents the Sand Dunes with a unique opportunity for this park and its many public and private partners to protect a truly world-class and very unique ecosystem. All partners will cooperate in a way that allows the flora and fauna to exist without artificial barriers. The park will work with others in the San Luis Valley region to ensure that this special area is seen as a positive part of the overall economy and contributes to the vitality and "sense of place" in this unique area of the state. The park will be proactive in contributing to the overall tourism aspect of the valley's economy. In particular it will focus on increasing visitation from a wider geographic and even international arena. We will work with partners to encourage longer visitor stays by facilitating more high quality experiences leading to lasting memories of this place through education, outstanding customer service and modern convenient facilities.

- Provide inspiring, safe, and accessible places for people to enjoy the standard to which all other park systems aspire.

The park is providing over 300,000 visitors per year with a very safe, educational and enjoyable experience. Park exhibits and programs exceed visitor expectations. Many visitors comment that this park is one of the best they have visited with respect to facilities and educational programs. Park staff is committed to continuing to improve.

 - Rehabilitate high-priority historic buildings to good condition, and help communities to preserve their history through programs like Preserve America.

The park's two historic buildings are in good condition and will be maintained in that condition.

- Restore native habitats by controlling invasive species and reintroducing key plant and animal species.

The park has a number of invasive species and has an active program to control invasives. Native trout reintroduction is planned when funding is available for some stream segments.

FCI in this park has improved dramatically in the past two years and we will continue to make improvments to the Index.

- Improve the natural resources in parks, as measured by the vital signs developed under the Natural Resource Challenge.

Vital signs are developed and we are working to determine if the park has key indicator species for monitoring global climate change.

The park is working with its Friends group to secure funding for additional cultural resource surveys so that the new lands are inventoried and resources are documented. Two more years is needed to complete the process.

- Serve as the Preeminent resource laboratory by applying excellence in science and scholarship to understand and respond to environmental changes. Great Sand Dunes will be known as a park focused on quality and focused research. It will utilize its unique environmental setting to be a setting for global climate change research.

The park has a very unique environmental setting that lends itself to climate change monitoring. For example, the high tundra snows melt and flow directly to the park's sand ecosystems. Researchers from many diciplines are looking at the adaptabiliy of the flora and fauna in such a narrow corridor.

- Encourage children to be future conservationists. Great Sand Dunes is a children's playground and one that brings families back for generations. The park will continue to play a major role in children's education by providing quality programming for all concerned.

The park has a very active educational program for many levels and age groups. All programs carry a message regarding conservation and preservation of resources. We also provide many programs to area wide school groups.

The park staff will find products and utilize green practices in all aspects of park operations. The park has now obtained waters of outstanding quality designations for 15 of its water sources and will seek to increase the numbers of waters with this designation.

- Encourage collaboration among and assist park and recreation systems at every level; federal, regional, state and local to help build an outdoor recreation network accessible to all Americans.
 - Rehabilitate over 2,000 miles of trails within or connected to national parks, including trails accessible to those with disabilities.

Old forest trails in the new park are being rehabilitated with the assistance of youth corp and other cooperative ventures. Current technology does not allow for extensive accessible trails in a very windy and sandy environment.

- Focus national, regional, and local tourism efforts to reach diverse audiences and young people and to attract visitors to lesser-known parks. The park will work with all partners to reach a wider national and international audience.
 - Increase visitation by 25 percent at lesser-known parks through a national tourism effort aimed at helping people to discover the breadth of parks and experiences.

The park is working with the local tourism offices and the State of Colorado to let a much wider audience know that Great Sand Dunes is now a National Park and as such has much more than spectacular dunes in its tourism portfolio. This year we have increased visitation by 10%.
