

Edgerton Highway Trails

Brenwick-Craig Road Easement


(MP 101.5W Richardson Hwy) This 17b Easement provides access to public lands around Klutina Lake across privately owned Native land. A 60 ft. wide easement proceeds approximately 23 miles along the Klutina River and bluffs and terminates at a one-acre site easement that allows camping for up to 24 hours and parking. It is recommended for high clearance or 4-wheel-drive vehicles only. At the one-acre site, the easement changes to 25 ft. wide with a gross vehicle weight limit of 3000 lbs. The 25 ft. easement extends approximately 7 miles ending on public lands. Camping or parking on or within the easement, outside the one-acre site, is prohibited. This is an easement through private lands and anyone wishing to park, camp, or exit from the easement must receive a permit from Ahtna Inc. in Glennallen. This includes accessing the Klutina River for fishing or to launch a boat.

Tonsina River Easement

(MP 12.3S Edgerton Hwy) A 25 ft. wide, 17b Easement that provides foot access to the bluffs overlooking the scenic lower Tonsina River. The trail is approximately 2 miles and is excellent for hiking. There is parking at the trailhead.

Liberty Falls Easement

(MP 23.5S Edgerton Hwy) A 25 ft. wide, 17b Easement that provides foot access to excellent views of the Wrangell Mountains and Copper River. The one mile trail is in good condition but is fairly steep. There is parking at the trailhead.



What is a 17b Easement?

Section 17(b) of the Alaska Native Claims Settlement Act reserved easements across privately owned Native land to maintain access to public land.

- Respect private land by staying on the easement and not littering on or damaging private land.
- Know and adhere to the allowable uses for each easement.

Richardson Highway Trails

Coal Mine Road

(MP 254E Richardson Hwy) This unimproved road and associated network of trails provides access to lakes stocked by ADF&G and amazing views of the Alaska Range and Delta River. Primitive campsites exist that are not maintained. It is recommended for high clearance, 4-wheel-drive vehicles, and mountain bikes. Please take your garbage home with you.

Fish Creek Trail

(MP 190E Richardson Hwy) This trail provides access to Fish Lake and the Gunn Creek area. Fish Creek is an anadromous (salmon bearing) stream so cross only at existing crossings. This trail starts on State of Alaska land. Primary use is motorized and snowmachine, however hiking is also possible on this trail. There is parking at the trailhead.

Middle Fork Trail

(MP 169.5W Richardson Hwy) The trail begins in a state highway gravel pit and continues westward approximately 8 miles towards the Gulkana National Wild River. Users must stay on the trail at all times. The trail boasts outstanding views of Paxson Lake and the surrounding hills. Primary use is motorized, however hiking is becoming more popular. Please respect all users of the trail. This trail is within the State of Alaska Sourdough Controlled Use Area, so motorized hunting restrictions apply. There is parking at the trailhead.

Gillespie Lake Trail

(MP 168.7W Richardson Hwy) This short foot trail provides access to Gillespie Lake. There is a large parking area at the trailhead.

June Lake Trail

(MP 166.5W Richardson Hwy) This short foot trail provides access to June and, via canoe, Nita lakes. A side road across from the trailhead can be utilized for parking.

Mile 141 Easement



(MP 141W Richardson Hwy) A 25 ft. wide, 17b Easement that provides foot access to the Gulkana River through privately owned Native lands. There is a one-acre site easement at the end of the trail at the river, which allows camping for up to 24 hours. The beginning of this easement is very steep and slippery during wet conditions. The parking area near the trailhead is on private land and users wishing to park here must pay a fee.

Poplar Grove Easement

(MP 137W Richardson Hwy) A 25 ft. wide, 17b Easement that provides foot access to the Gulkana River through privately owned Native lands. There is a one-acre site easement at the end of the trail at the river, which allows camping for up to 24 hours. The beginning of this easement is very steep and slippery during wet conditions. The parking area near the trailhead is on private land and users wishing to park here must pay a fee.

Diverse landscape - Diverse opportunities

- Car camping with the family on Coal Mine Road is the perfect opportunity to teach youth about nature.
- Explore the game trails on tundra-covered ridges by taking a hike in the Tangle Lakes region.
- Experience the soothing sound of loons while canoeing on Gillespie Lake.
- Fight and land a salmon after a short hike from the Richardson Highway at Mile 141.
