As you know, EPA has come under increasing attack recently for lack of coordination and lack of clear policies in the regulation of offshore oil and gas activities. These criticisms result from anxiety within the industry and the Departments of Interior and Energy concerning delays in permit issuance, overly restrictive conditions, and an apparent lack of coordination within the Agency. Congress and the White House have also taken an interest. Specifically, the following factors are involved:

1) delays in the commencement of exploratory operations in the

Flower Gardens and Santa Barbara; 2) lack of coordination between the "no discharge requirements" in NPDES permits and the designation of ocean dumping sites; 3) inconsistencies between the criteria used to issue permits in the NPDES and ocean dumping programs; 4) confusion over effects of and appropriate control mechanisms for drilling muds; and 5) inconsistencies between Regions in permit and environmental assessment requirements.

Over the past several weeks a series of meetings have been held in which many of you have been involved. At these meetings it became apparent that a central committee was needed to coordinate and provide direction for the many Agency activities related to regulation of the oil and gas industry on the Outer Continental Shelf (OCS). We agreed to form this committee and designate the Office of Water Enforcement as the lead office. I suggest we all serve as members of the committee and assign appropriate staff to coordinate the work and raise issues when necessary. In accordance with this format, I am designating Bill Jordan, Chief, Industrial Permits Branch, as staff chairman of the committee which has been dubbed the Outer Continental Shelf Coordination Committee. The purpose of the committee will be to coordinate policy issues and the various program office tasks relating to OCS oil and gas regulation to ensure consistency in Agency actions.

The OCS Coordination Committee will not supercede the responsibilities of the program offices but will provide coordination of OCS actions with the primary objective of consistent, well-supported, and expeditious NPDES permitting. For example, the Ocean Programs Branch will continue to oversee and coordinate technical studies (Drilling Mud Task Force, Flower Gardens Task Forces, etc.), ORD will be responsible for conducting studies on impacts and controls and should serve as the agency spokesman on the results of these studies, and the other program offices will be responsible for the individual tasks within their jurisdiction.

The committee will operate through subcommittees responsible for completing the specific tasks which have been identified. Attached (see Attachment 1) is a draft description of the OCS Coordination Committee and the various subcommittees as well as proposed membership assignments. Several of these subcommittees are existing work groups. Please review the descriptions and proposed assignments carefully and recommend changes by June 13, 1980.

The subcommittees will be responsible for completing a number of ongoing OCS tasks within the Agency which are preliminary to further permit issuance. As an example of a schedule and milestones for one of these tasks, we have attached (see Attachment 2) a summary and workplan for one of the tasks of the

Permits Oversight Subcommittee. Such a plan for each task is necessary to organize these tasks, to identify issues, to provide increased coordination between offices, and to ensure timely completion of each task. I am, therefore, requesting that each subcommittee identify the tasks under its jurisdiction and prepare a summary and work-plan for each (also by June 13, 1980).

We must move quickly to resolve the problems associated with regulating the offshore oil and gas industry because of the increasing attention energy development will receive over the next few years.
