DFC Masterplan / Redevelopment *Update*

Denver Federal Center Master Plan Completed



GSA has just completed the Final Federal Center Site Plan Study – a new 20-year Master Site Plan, and an Environmental Impact Statement (EIS) for the Denver Federal Center, Lakewood, CO.

Over 330 individual comments were received on the April 2007 Draft Study during the public

comment period that ended in June 2007, covering a wide range of topics from open space, to traffic, to site security. GSA and its extensive team of consultants and project participants has worked diligently to review and consider all of the comments, evaluate and respond to questions and concerns, and develop a "preferred alternative" for the Final Master Site Plan and Final FIS

Key components of the plan include:

- A mix of land use districts centered around a "Federal Ouad."
- Transit Oriented Development (TOD) higher-density, pedestrian-friendly districts in proximity to transit adjacent and around the new RTD Intermodal Station;
- A stepped-down density pattern from the north to the south of the Federal Center site approaching Alameda Avenue, and from the west to the east approaching Kipling Street, integrating new uses with existing development;
- Increasing community recreational amenities for federal tenants and the general public in both active and passive open space;
- An aggressive building demolition and replacement plan;
- Preservation and enhancement of natural systems and open space areas.

GSA has also completed the EIS that evaluates the potential impacts of implementing this redevelopment plan on the Federal Center. GSA anticipates filing

of a Record of Decision

(ROD) for the EIS in March 2008. Filing of the ROD officially completes the process and clears the way for GSA to begin actual implementation of the plan. Many follow on studies, analysis and individual project planning will occur later this year.

In this issue...

Completion and future implementation of the new Federal Center Master Plan, adds to the already exciting changes happening on the site. On September 19, 2007, GSA closed on the sale of 65 acres on the west side of the Federal Center to the City of Lakewood. The land was in turn sold immediately to St. Anthony Hospital and to the Regional Transportation District (RTD) for the construction of St. Anthony West Hospital and an RTD intermodal light rail transit station. Construction will begin in the Summer of 2008. In this very unique and precedent-setting market value land sale, GSA retained the sale proceeds and will utilize it for capital infrastructure improvements to the Federal Center.

Although the Federal Center Master Plan is a long-term vision and will occur in stages over the course of 20 years, it sets forth a clear and exciting strategy and framework for meeting the current and future needs of our federal tenants and the larger community.

Environmental News

State of the Regional Recycling Program FY07



The GSA Recycling Program was first created in 1983 as a result of Executive Order 12780 that required federal agencies to promote cost-effective federal waste reducing and recycling of reusable materials. At that time, the only material that had a value for recycling on a nationwide scale was white office paper and related products. In 1998, President Clinton signed Executive Order 13101 which simplified the recycling requirements and included the requirement for purchasing products that contained recycled content materials. Tracking of the recycling stream and the purchase of green products continued to be problematic; however, strategies were beginning to be implemented to standardize the process. In January of 2007, Executive Order 13423 was signed by President Bush that placed further importance on recycling and green purchasing activities.

During FY2007, the Rocky Mountain Region successfully implemented and tracked waste and recycling stream activities. This was coupled with using GSA Advantage to track agency purchasing trends. The most notable recycling successes are as follows:

Building 41, Denver Federal Center

- Created a trash room complete with compactor and bailer, estimated capacity is 1 ton of trash and 800 lbs of cardboard processed per week, estimated recycling diversion rate is 36%. The EPA minimum requirement is 35%.
 - o Total Waste = 40,030 lbs/20.02 tons
 - o Total Recycling = 14,430 lbs/7.22 tons
- Installed collection centers for recyclable drink containers and related items
 - o Currently designing the next phase of the improved recycling program
- Denver Federal Center
 - o Implemented a single stream program, collected 52 tons of materials at the close of FY07
 - o Implemented a demolition recycling program that processed 30 tons of debris
 - o Hosted its first Home Electronics Collection event. A total of 141 people attended and 7.25 tons of electronics were recycled.

After the release of Executive Order 13423, the Rocky Mountain Region has seen an increase in tenant interest for assistance with their building's recycling activities. Plans to meet those needs and interests are to:

- Implement single stream collection and improved waste collection activities one building per year.
- Put into practice a battery collection program in all regional GSA owned properties.
- Host annual electronics challenge to encourage federal employees to recycle old electronics in an environmentally preferable manner.
- Create and employ a green team in Building 41 at the Denver Federal Center.
- Provide assistance to tenant agencies to start their own green teams.
- Attain the minimum EPA Waste Reduction rate of 35% for all facilities both government owned and leased.
- Capitalize upon local markets for recycling construction and demolition materials on every project.

Get Your Dose of Vitamin D

Did you know the DFC Solar Park went online January 4, 2008, and is now producing enough energy to heat approximately 145 homes? The solar park has produced 127,000 kWh of power since going on line. In February we are averaging 3,400 kWh/day with a high of 6,380 kWh on Sunday, February 20.

Building 42 has been demolished, remediated and backfilled. Contractors are now waiting on warmer weather to begin paving for a future parking lot. All recyclable materials from the demolition have been sent to the DFC recycling area where 45,000 tons will be stored for future backfill projects.

The DFC single-stream recycling program has been such a success that we are adding additional recycle dumpsters at the following locations starting the first week in April:

- Bldg. 20 east parking lot
- Bldg. 25 east parking lot
- Bldg. 50 south parking lot
- Bldg. 55 west parking lot
- Bldg. 75 parking lot

Introducing Your Investigative Team

In November 2007, the General Services Administration, Office of Inspector General (GSA-OIG), opened a new investigation office located in the Denver Federal Center.

The GSA-OIG performs investigations pursuant to violations of GSA programs and operations. These can be criminal, civil and/or administrative in nature with emphasis on white collar crimes. Typically, the Office of Investigations conducts investigations relating to violations of Title 18, United States Code: including fraud, bribery, larceny, embezzlement, collusion, false claims, and conflict of interest. These investigations also extend to numerous other federal statutes, where the violations may be in the form of threats, thefts, forgeries, extortion, or embezzlements, effecting the programs and operations of the GSA. Enforcement activities can include interviews, undercover operations, surveillance, arrests, and searches warrants.

These investigations are often worked in conjunction with other agencies such as the Federal Bureau of Investigation (FBI), Defense Criminal Investigative Service, other Offices of Inspector Generals, and military criminal investigative organizations.
