## Vision Statement

It is the mission of Colonial National Historical Park to preserve the cultural, scenic and natural resources of Jamestown, Yorktown, Green Spring, Cape Henry and related areas, to interpret the colonial era from 1607 to 1781, and to maintain the Colonial Parkway and its surrounding resources for the benefit and enjoyment of the people. This mission statement grows from the park's legislative mandate found in Public Law 510, enacted by Congress on July 3, 1930 and supplemented by Public Law 666, enacted on June 5, 1936.

Colonial NHP is located adjacent to a rapidly developing suburban/urban area. Potential impacts from such development include visual intrusions on the historic scene, boundary encroachments from adjoining development, environmental impacts such as increased storm water runoff into the park, and increased recreational pressures, such as unauthorized mountain bike use on historic earthworks or unauthorized swimming and boat launching at beach areas along the Colonial Parkway.

It is the desire of park management to effectively balance the preservation of resources and the historical interpretation of the park while addressing the concerns of increasing visitation and recreational use. Through education and interpretation, we hope to inspire our visitors to be stewards of the historical riches this park is empowered to protect.

As we face the Centennial Challenge of 2016, we are also challenged with attrition of experienced staff and budget erosion. We will engage our volunteers and our partners, APVA Preservation Virginia and Eastern National, to work with us to renew our educational programs and connect our visitors with the site's significant history, from the experiences of the first settlers at Jamestown to the soldiers on the battlefields of Yorktown. We will strive to stay abreast of technological change to connect our youth through interactive computer media and electronic handheld devices.

We will be more aggressive in educating our visitors on how to protect the park's natural and cultural resources while experiencing the quiet serenity of the Colonial Parkway, the reverence of the historic battlefields, and activities of the bald eagles and other wildlife in the park. We will promote "Leave No Trace" programs and trash free parks, strive to provide visitors with a safe and secure visit, and encourage visiting youth to be future conservationists. It is, after all, our youth that will inherit these riches we preserve.

The coordinator will be dedicated to managing the volunteer program and recruiting new volunteers from within the community.

- X Promote a safety and health culture for all employees and visitors.
  - Reduce the number of employee lost-time incidents and serious visitor injuries by 20 percent.

Supervisors will counsel employees before and after injuries about safe practices and provide special training when necessary. Employees will be provided with safety equipment for hazardous duty tasks, and refreshed on safe practices with tailgate safety sessions.

All staff will be observant and provide needed assistance and guidance to keep our visitors informed of all safety concerns.
