Scope of Social Services

Under SIN 595-28, your agency may issue a task order for essential personal support services from pre-qualified vendors. This SIN provides a full range of human-resources employee assistance and related social services, including:

- Employee Assistance Programs (EAP);
- Vocational Therapy;
- Rehabilitation Therapy;
- Physical and Occupational Therapy;
- Child, Youth and Family-Support Services;
- Emergency Response and Relief Services:
- Personal Care:
- Day Care;
- Religious and Human-rights Consulting;
- Veterans' Re-adjustment Counseling;
- Benefits Compensation Consulting;
- Health and Wellness Training;
- Stress Management Consultation;
- Substance-abuse Services; and
- Legal Counseling.

Examples of Agency Use of Social Services SIN

The Social Services SIN may benefit a wide array of customer agencies, especially the civilian and military agencies with personnel subject to high levels of work-related stress including overseas deployments. This offering may be especially useful to agencies supporting military and civilian personnel and their families, such as DoD, the U. S. Department of State and the U. S. Department of Veterans Affairs. Services include physical and occupational therapy, daycare, re-adjustment counseling and stress management.

These services can also be used to help agencies assist victims of floods, fire and other disasters with grief counseling, emergency response and relief, family support services, legal counseling, and career counseling.

In federal agencies, there is a growing need to provide traditional EAP. EAP is a critical program benefitting both managers and employees. EAP services available to agency employees include services for stress and relationship problems, work-life issues, professional and personal development and substance abuse services.
