RELOCATION: Travel Expenses – Not Paid

Travel, transportation, and relocation expenses associated with reporting for duty in this position will be the responsibility of the employee.

CONDITIONS OF EMPLOYMENT:

- > One permanent full-time position. The incumbent of this position is subject to call back and/or standby work.
- > If you are a male, born after December 31, 1959, and you want to be employed by the federal government, you must (subject to certain exemptions) be registered with the Selective Service System.
- In accordance with Chapter 12, Indian Health Manual, IHS Employee Immunization Program, selected candidate will be required to submit proof of immunity to the following diseases: Rubella and Measles.
- ➤ In accordance with P.L. 101-630 Indian Child Protection Act, applicants must complete the attached addendum and submit it to the Human Resources Office with their application. (See REQUIRED DOCUMENTATION).

DUTIES AND RESPONSIBILITIES:

The purpose of this position is to provide comprehensive nursing care services for ambulatory patients in the following clinics: Family Medicine, General Medicine, Pediatrics, Diabetes, Prenatal, High Risk OB/GYN, Colposcopy, Rheumatology, Renal and Allergy Clinics. Provides comprehensive professional nurse services to neo-natal, pediatrics, adolescents, adults and geriatric patients. Observes and assesses patients, documents the patient's condition, vital signs and measurements on the medical record and initiates plan of action to carry out nursing care according to the appropriate nursing care guidelines and prescribed medical treatment. Supports the patient and/or family in the integration of the patient plan of care toward changes to improve health by assessing patients and/or families need for education and provides and documents educations. Instructs patients and families on how equipment and supplies are used such as nebulizers, crutches, splints, dressings, and dressing changes, etc. Instructs patients and family on the use of medications, contraindication of medications and the value of proper follow-up. Performs a range of treatment procedures that includes using extensive and complex sterile dressing changes, monitoring intravenous fluids, inserting catheters, administering medications, caring for contagious patients, setting up and giving treatments that require oxygen and suction. Performs a range of diagnostic support duties which include taking vital signs, taking specimens, calling the laboratory for lab reports, and recoding lab reports given over the telephone. Assists in the care of emergent patients, i.e. trauma and/or cardio-pulmonary arrest, respiratory distress by assisting the physicians and nurses with resuscitation and stabilization efforts. Maintains adequate supplies in all areas of Ambulatory Care unit and is responsible for general upkeep of equipment and unit cleanliness. Assists with the functioning of specialty clinics such as Maternal and Child Health, Chronic Disease, and Preventive Health.

COMPETITIVE AND EXCEPTED SERVICE OUALIFICATION REQUIREMENTS:

Basic requirements:

Licensure: Candidates must be currently licensed to practice as practical or vocational nurses in a State or territory of the United States or the District of Columbia or must have applied for a license to practice. Applications of candidates possessing a license must be accompanied by a certified or photostatic copy of the license, a notarized statement attesting to the fact, or a citation of the license number and State issuing it. Non-licensed candidates who have completed their training may be appointed subject to obtaining the required license during the probationary period. Those not licensed must furnish the date on which they applied for a license and the jurisdiction involved. No person appointed pending licensure may be retained beyond the probationary period if license has not been attained.

In addition to meeting the basic requirements, candidates must have 52 weeks of Specialized Experience equivalent to at least the GS-5 level.

Specialized Experience: Qualifying experience includes nursing care work in a hospital, outpatient clinic, nursing home, or other supervised medical, nursing, or patient care facility that provided a practical knowledge of human body structure and sterile techniques and procedures, performing such duties as:

- Providing pre- and post-operative patient care.
- Observing, recording, and reporting change in behavior in mentally ill patients.
- Assisting surgeons and registered nurses in operating room activities, including passing instruments, maintaining sterile conditions, and draping and positioning patients.
- Setting up and operating special medical equipment and apparatus.

TIME-IN-GRADE REQUIREMENTS: Merit Promotion candidates must have completed at least 52 weeks of service no more than 1 grade lower than the position to be filled.

EVALUATION METHOD AND RANKING FACTORS: Evaluation will be made of the extent to which experience, education, training, self-development, performance appraisal, outside activities, and/or awards demonstrate that basically qualified candidates possess the Ranking Factors-KSAs described below. **It is to the applicant's advantage to address the following KSA's on a separate sheet of paper.**

- 1. Knowledge of practical nursing care principles, procedures and technique.
- 2. Ability to observe and report physical and emotional changes for inclusion in the patient's care plan.
- 3. Ability to prepare and administer medications.
- 4. Ability to respond to emergency situations.

WHO MAY APPLY:

Merit Promotion Plan (MPP) Candidates: Applications will be accepted from status eligibles (e.g., reinstatement eligibles and current permanent employees in the competitive federal service) and from current permanent IHS employees in the Excepted Service who are entitled to Indian preference.

Excepted Service Examining Plan (ESEP) Candidates: Applications will be accepted from individuals entitled to Indian preference. Current permanent IHS Excepted Service employees and competitive service employees or reinstatement eligible entitled to Indian preference may also apply under the provision of the Indian Health Service Excepted Service Examining Plan.

Candidates <u>MUST INDICATE</u> whether their application is submitted under the IHS Excepted Service Examining Plan, the IHS Area Merit Promotion Plan, or both.

Applications will also be accepted from individuals eligible for non-competitive appointment (e.g., applicants eligible for appointment under the Veterans Readjustment Act, the severely handicapped, those with a 30% or more compensable service-connected disability).

Vacancies may be filled through Office of Personnel Management's delegated Direct Hire Authority (D.H.A). The Direct Hire Authority has been authorized by the Homeland Security Act of 2002 and Part 337, Subpart B, Title 5 of the Code of Federal Regulations (5 CFR). If filled utilizing D.H.A., the following is applicable: all applicants who meet the basic qualification requirements will be forwarded to the Selecting Official for consideration. The "rule of three", Veteran's preference and traditional rating and ranking of applicants do not apply to the Direct Hire process. **Indian Preference does apply.**

Indian Preference: Indian Health Service is required by law to give absolute preference in employment to qualified Indian preference candidates.

Under the <u>Veterans Employment Opportunities Act (VEOA) of 1998</u>, veterans who are preference eligible or have substantially completed 3 or more years of continuous active service may apply for <u>permanent</u> positions as a merit promotion candidate; however, veterans' preference is not a factor in these appointments. Candidates must submit a copy of their DD-214 as proof of eligibility.

Reasonable Accommodations: This agency provides reasonable accommodations to applicants with disabilities. <u>Career Transition Assistance Program (CTAP)/Interagency Career Transition Plan (ICTAP):</u> Surplus or displaced employees covered by the U.S. Department of Health and Human Services CTAP program or the ICTAP program for all agencies, may apply and will be given special selection priority if determined to be eligible and well qualified. <u>Well qualified</u> is defined as meeting all education, experience, knowledge's, skills and abilities (KSA's) with a score in the above average range of a four-level crediting plan for all KSA's. REQUIRED DOCUMENTATION:

- ➤ Verification of Indian Preference: Applicants who wish to receive Indian Preference MUST submit the BIA Form 4432, Verification of Indian Preference for Employment in BIA and IHS only. This certifies the applicant as an Indian as defined by the Indian Health Manual, Chapter 3, Indian Preference, dated December 22, 2008. Indian preference will not be given unless the BIA Form 4432 is attached to the application/Résumé.
- > OF-306, Declaration for Federal Employment: Must be fully completed and submitted with current dated signature to determine your suitability for Federal employment, to authorize a background investigation, and to certify the accuracy of all the information in your application. If you make a false statement in any part of your application, you may not be hired; you may be fired after you begin work; or you may be fined or jailed.
