- (1) West of the Sierra Nevada crest.
- (2) East of the Sierra Nevada crest.
- (3) The portion of the county right of a line from the Gold Lake Road Summit, along the western border of the Plumas-Eureka State Park, to White Cap Peak, to Lee Summit on California State Highway 70, to Grizzly Ridge, to Grizzly Peak, to Mt. Jura, to Evans Peak, to the Lassen County Line along Keddie Ridge.
- (4) The portion of the county left of the border described in (3).
- (5) The portion of the county right of a line from the southern San Bernardino County border along the western border of the Joshua Tree National Monument to the junction with a north-south line through Desert Beach connecting the Salton Sea, and then southward along the western edge of the Salton Sea to the southern border of Riverside County.
- (6) The remainder of the county left of the line described in (5).
- (7) That area of the county not assigned to SGX or PSR as described in (8) and (9).
- (8) That portion of the county southwest of a line which extends from the triple point of Kern, Los Angeles and San Bernardino counties eastward to the northwest corner of the Twentynine Palms Marine Corps Training area (34.74N, 116.42W) then following southwestward along the western border of the Training Area until it begins veering off to the southwest at 34.36N, 116.40W extending southwest to the intersection of California Highway 247 with Mikiska Boulevard (34.32N, 116.48W).

- (9) WFO PSR is assigned CWA for all Joshua Tree National Park, including the small portion which resides in San Bernardino County.
- (10) All of county except Surprise Valley as described in (11).
- (11) The extreme eastern portion of the county which contains the Surprise Valley. This area lies to the east of the USFS boundary on the east side of the Warner Mountains. The USFS boundary is approximately 5000 elevation.
- (12) All of the Tuolumne County except for the Yosemite National Park portion of southeast Tuolumne County.
- (13) The Yosemite National Park portion of southeast Tuolumne County.

- (14) Areas of San Juan County designated as the Glen Canyon Recreation Area and the area north of a line along the Utah Arizona border from Lake Powell east to the intersection of the Utah-Arizona border and the southwest ridgeline of Navajo Mountain separating the drainages of Horse Canyon and Dome Canyon...continuing northeast along this ridgeline to the crest of Navajo Mountain and then down the ridgeline separating the drainages flowing directly north toward Lake Powell from those flowing east into Piute Creek...at

the intersection of this ridgeline and the continuous 4500 foot (MSO) contour line, following the contour line to the east until it intersects the ridgeline separating the drainages with flow west to the upper reaches of Lake Powell from those flowing east or northeast into Algid Wash...then following this ridgeline north to the San Juan River.

- (15) The area north of a dividing line in Gila County starts from the east at the point where the Black River (which delineates the southern Navajo County border) crosses into Gila County. The dividing line then follows the Black and Salt Rivers to a point where the Salt River crosses State Route 288. From State Route 288, it then parallels Roosevelt Lake's northern shore roughly along the dirt road just north of the lake. The dividing line then turns north and intersects State Route 188, at a point half-way between Punkin Center and Jake's Corner. From State Route 188, it turns due west to the Maricopa County border.
- (16) The area south of the line described in (14).
- (17) The area northwest of a dividing line in Pinal County which starts from the western Pinal County line, 10 miles north of the Pia County line. It extends northeast passing 1 mile south of Arizona City, then crosses Interstate 10 at a point 8 miles south of Casa Grande. From Interstate 10, the dividing line continues northeast and crosses State Route 79 at a point 3 miles south of Florence, and from there it continues northeast to the Gila County line at a point 5 miles south of U.S. 60, or 10 miles southeast of Superior.
- (18) The area southeast of the dividing line described in (16).
