2007 Timeline



- **September 26th:**
 - Last day to notify the California Area office about data problems that would significantly affect workload.
 - CAO begins exporting weekly (NPIRS begins posting weekly workload reports.)
- **October 31st:** Final deadline for exporting data to NPIRS.
- **November 3rd-14th:** Reserved for resolving problems, if possible, with data that was already exported by the October 31st deadline.
- **December 6th:** NPIRS posts the official 2007 User population.
- **December 11th:** Request for user population adjustments due to CAO.

Review workload report(s)

- Monthly export timeline
 - Files exported by the 1st of each month
 - NDW loads data & performs data check process
 - Workload reports are posted mid-month
- Recommended review schedule
 - Monthly (October 1 thru September 30)
 - Weekly (October 1st – 31st)
- Navigating to your report (Demo)
 - [National Data Warehouse](#)
- Report comparisons
 - Data transmission issues
 - CHS/Dental package – ‘link to PCC’ is turned on
 - Data exports are timely
 - Staffing or available health services
 - Coding and data entry backlog



NPIRS Business Rules

- Registration records:
 - Valid ASUFAC
 - Valid chart number
 - Valid First Name or Middle Name
 - Valid Last Name
 - Initial Un-duplication



NPIRS Business Rules

- **Workload Reportable Encounters**
 - **Direct outpatient**
 - Service Type and Service Category
 - Clinic code and Provider code
 - Location of Encounter
 - Valid date of Service (within the current FY)
 - **Direct Inpatient – N/A**
 - **CHS (Inpatient/Outpatient)**
 - 'apcrun': Service Type and Service Category
 - 'STATRECS': Record Code
 - 'chs638': Record Number
 - **Dental** (see reference for specific export file formats)
 - Identified by Clinic code, provider code, and ADA codes



NPIRS Business Rules

- User Population Reports:
 - Indian Status
 - Tribe Code = '000' – '997'
 - Tribe Code = '998' or '999'
 - and Beneficiary code = '01'
 - And Indian Blood Quantum = '1' or '2' or '3' or '4'
 - Active Flag
 - Based on workload reportable visit in any of the 5 encounter tables (APC, Inpatient, CHS Out/In, Dental)
 - Community of Residence
 - Determined by CHSDA – reflected in Standard Code Book (SCB)
 - Timeframe of visit must be between 10/1/2004 – 9/30/2007
 - Duplicate Flag
 - Secondary un-duplication process
 - Probabilistic matching: Name (First, Last, and Middle), SSN, DOB, and Gender.
