Sustainable Property Transactions: Doing Contaminated Site Redevelopments in a Downturned Market

April 6, 7, 8, 2009 Washington, DC

Explore how complex deals involving environmental contamination and sustainable development issues can be successfully managed—how sites get cleaned up and redeveloped. Employing environmental, legal, financial/accounting and risk management tools, the corporate dealmakers have a war chest of alternative environmental due diligence techniques and risk financing methods (institutional and engineered controls, stringent environmental agreements and environmental insurance, etc.) to get the transactions done with the able involvement of in-house and outside counsel, liability buyout and guaranteed fixed price remediation programs, and equity and debt financing firms. There will be sessions that demonstrate green building design, remediation, construction, evolving underwriting standards based on the LEED certification process and monetizing carbon finance assets in real estate transactions.

Community Action for a Renewed Environment (CARE) Grant Program RFP

Guidelines are now available for preparing proposals to receive financial assistance through the Community Action for a Renewed Environment (CARE) program. CARE is a unique community-based, community-driven. multimedia demonstration program designed to help communities understand and reduce risks due to toxic pollutants and environmental concerns from all sources. The CARE grant program works with the eligible entities to help their communities form collaborative partnerships, develop an understanding of the many local sources of risk from toxic pollutants and environmental concerns, set priorities, and identify and carry out projects to reduce risks through collaborative action at the local level. CARE's long-term goal is to help communities build self-sustaining, community-based partnerships that will continue to improve human health and local environments into the future. The objective of the CARE grant program is to work collaboratively within the community to investigate the effectiveness of the CARE process--whether this cross-Agency, multi-media program provides greater environmental benefits than either non-collaborative or single media approaches.

Smart Growth Implementation Assistance: 2009 Request for Application

Applications are due at 5:00 pm EST, April 23, 2009
The Development, Community, and Environment
Division in EPA's Office of Policy, Economics, and
Innovation is seeking applications for technical
assistance from communities that want to incorporate
smart growth in their future development to meet
environmental and other community goals. Eligible
entities are tribal, local, regional, and state governments,
and nonprofit organizations that have a demonstrated
partnership with a governmental entity.

Selected communities or states will receive assistance in the form of a multi-day visit from a team of experts organized by EPA and other national partners to work with local leaders. EPA plans to assist three to five communities over a period of twelve months. The Agency anticipates announcing the selected communities in fall of 2009.
