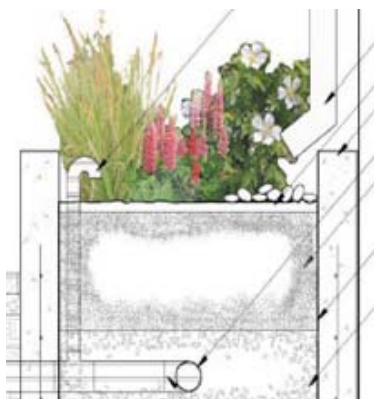

Green remediation is the practice of considering all environmental effects of cleanup actions and incorporating strategies to maximize the net environmental effects of those actions. The sustainable practices emphasize the need to more closely evaluate core elements of a cleanup project such as energy requirements and air emissions.

HUD Healthy Homes and Lead Funding

HUD recently released its "SuperNOFA" (notice of funding availability) for numerous grant programs including \$142 million for Healthy Homes and Lead Hazard Control Programs.

Programs and closing dates include:

- Lead-Based Paint, \$70.4 million, **July 10, 2008**
- Lead Hazard Demo, \$44.1 million, **July 17, 2008**
- Operation Lead Elimination Action Program (LEAP), \$17.5 million, **July 10, 2008**
- Lead-Technical Studies, \$2.2 million, **July 3, 2008**
- Healthy Homes Tech Studies, \$2.1 million, **July 3, 2008**
- Lead Outreach Grant, \$1.5 million, **July 17, 2008**
- Healthy Homes Demonstration Program, \$4.375 million, **July 17, 2008**
