SUBJECT: Reissuance of Realty Services Letters

- 1. <u>Purpose</u>. This Realty Services Letter (RSL) reissues expiring RSLs and provides a common expiration date for RSLs issued in the past year.
- 2. <u>Background</u>. RSLs expire 1 year after the date of issuance unless reissued.
- 3. <u>Effective Date/Expiration Date</u>. These instructions are effective immediately and will expire on July 31, 2008, unless modified, reissued, or canceled earlier.
- 4. <u>Cancellation</u>. PQ-2006-05, *Reissuance of Realty Services Letters and Lease Forms*, is cancelled.
- 5. Applicability. This RSL applies to all real property leasing activities.
- 6. Instructions/Procedures.
 - a. All RSLs listed on the Attachment are reissued.
