In order to participate in the live authentication session, please follow the instructions below. No prior RSVP is required for participation.

Connecting to the OPAL site:

• To bring up the GPO OPAL room, go to: http://www.conference321.com/masteradmin/room.asp?id=rs38bb0e4b3a5a.

- Install the "Talkcom" plugin by clicking the "Download Here" button.

 Once you have installed the plugin, you can then go back to the above URL (the same window you had open) and click in the orange box to enter the room.
- You may use any name that you choose to log in to the conference room.
 No password is required for this session.
 However, for a meeting we suggest you use both your first and last name.
- The first time you enter the OPAL online room, a small software applet will automatically download onto your computer allowing you to enter the room. The applet enables your computer to participate in the discussion.

What do I need?

To participate in the event, you will need to be connected to the Internet, access an Internet browser, have speakers (turned on) to listen to the audio presentations, and a microphone connected to (or embedded) in your PC. The microphone allows active participation in the Conference Room using voice-over-IP (VoIP) to speak in the Conference Room.

Content from the legacy Desktop's Cataloging & Indexing page has been migrated from PDF into HTML. This content will be undergoing an update by GPO staff in the near future. The original PDF versions, which were published in conjunction with various events, are available in the file repository < http://www.fdlp.gov/home/repository> under "Events."

With this launch, we have also posted new cataloging information as well. With an increasing number of digital reproductions being created by Federal agencies and by GPO and GPO's partners, GPO's Library Technical Information Services (LTIS) has formulated procedures for cataloging digital reproductions of a tangible document.
