## Vision Statement

The Timucuan Ecological and Historic Preserve contains many nationally significant resources within its vast expanse of salt marsh grasses and waterways, quiet wooded islands, and long views of a flat horizon. Some views within the preserve are pristine, while others display striking evidence of humans.

Located within the city of Jacksonville, Duval, and Nassau Counties, of Florida, the Timucuan Preserve encompasses approximately 46,000 acres, 75% of which are waterways and wetlands that form an extensive estuarine system between the Nassau and St. Johns Rivers where they meet the Atlantic Ocean. Much of the salt marsh is among the least disturbed on the southern Atlantic Coast.

Known prehistoric and historic archeological sites within the preserve number about 200. These sites provide evidence of human occupation in the region spanning 6,000 years. Fort Caroline National Memorial, an NPS area since 1950, commemorates the historic 16th century French colony, was assimilated as part of the Timucuan Preserve.

The Preserve provides large open areas for many types of recreation, especially water based, within the bound-aries of a major metropolitan area. Existing water-based recreation resources include the Intracoastal Waterway, fish camps, fisheries, and the St. Johns and Nassau Rivers.

The Centennial vision for the Preserve is to strengthen the Timucuan Trail State and National Parks partnership through a concerted effort of providing high quality, accessible, and safe recreational opportunities. This unique partnership seeks to provide cooperative management to over 50,000 acres of public and private lands owned by 200 agencies, private citizens and governmental bodies. The mission of the partnership is to increase public access to these lands in a seamless experience package for all visitors.

This partnership has in the past cooperated to do many things that would have been impossible for the partners to do singularly. Such as the purchase of thousands of acres of land, restoration and opening to the public of a 1920's era resort club as a multi-use facility, and the collaboration and funding to construct a bike path. Now the City and the NPS will embark on another project that will provide an improved and safe boat launch for visitors.

- X Provide inspiring, safe, and accessible places for people to enjoy the standard to which all other park systems aspire.

The current boat ramp at Cedar Point is in an unsafe condition and has caused damage to several visitor vehicles as they attempt to use the boat launch. As a result of the poor condition of the ramp, visitors launch from areas next to the existing ramp. This has caused extensive damage to the salt marsh grass beds on either side of the existing ramp. The marsh grass provides erosion protection to the shoreline.

The National Park Service and the City of Jacksonville are striving to provide increased recreational opportunities and as such are involved in the rehabilitation of this boat ramp thereby making it accessible to more visitors.

The current FCI of the Cedar Point boat ramp (asset #12938) is 0.732 placing it in Serious condition. This project would decrease the FCI to 0.0 which would raise the asset to a Good condition.

The repair and rehabilitation of this boat ramp will increase visitation to an area within the park that is underutilized. The Cedar point area of the park is located within the most rapidly developing area of the county. Currently, few opportunities exist in the north side area for visitors to access the water resources.
