CEO Delegation Visit Troops in the War Zone

A delegation of Secretaries of State from five states, invited by the Secretary of Defense, visited the troops in Kuwait, Iraq. Afghanistan, and Germany. The delegation The Secretaries expressed their consisted of Secretary Debra Bowen of California, Secretary Kurt Browning of Florida, Secretary Pedro Cortes of Pennsylvania (also President of the National Association of Secretaries of State, NASS), Secretary Todd Rokita of Indiana (immediate Past President of NASS), and Secretary Delbert Hosemann of Mississippi.

These Secretaries are Chief Election Officials of their states and also, via their positions in national election organizations, represent election officials in all the states. The delegation members visited the combat zones to promote voting participation and to learn about the voting assistance programs and service members' voting experiences.

delegation met with the Installation Commander and the Installation Voting Assistance Officer. They received an indepth briefing of the Installation's voting assistance program and the processes and procedures provided to the service members. They also held question and answer sessions. The delegation also met with the troops both individually and in panel discussions to learn about service members' absentee voting experience.

In addition, the delegation was briefed by Military Postal Service Agency personnel at Arifjan, Bagram, and Balad, and learned about the ballot mailing process at each stop. The delegation visited the military hospital in Balad Air Base, Afghanistan and later visited Landsthul Army Medical Center in Germany. Throughout their visit, the delegation continuously stressed to the

service members the importance of voting and having their voices heard.

appreciation of the Department of Defense and Federal Voting Assistance Program for providing them the opportunity to learn and experience so much in such a short time. The Secretaries said they were impressed with how the voting assistance officers made sure all service members were knowledgeable of their states' voting procedures and requirements. The Secretaries expressed their eagerness to work with their state officials, including state legislators, to encourage improvements to the absentee voting process, especially by adding alternatives to the by-mail process, such as emailing and use of the internet.

Local election officials—vou may be receiving Federal Write-In Absentee Ballots (FWABs) from persons covered by the UOCAVA. These FWABs may be from citizens who have moved or been deployed since submitting their request or citizens who did not receive their state ballots. Many in these situations opt to use the FWAB.

Please help ensure that all eligible UOCAVA citizens are entitled to vote in this year's general elections for Federal offices. If you have questions about the FWAB and who can use it, please do not hesitate to contact the FVAP.
