JUNE STAKEHOLDER MEETING

On Wednesday, June 28, Grants.gov held its bi-monthly stakeholder meeting at the Hubert H. Humphrey Building.

John Etchevery opened the meeting and discussed Grants.gov's continuing work with each agency to support their goal of posting 75 percent of their discretionary applications on Grants.gov, the recent budget discussions with OMB, and record-setting submissions and help desk usage. Over 10,000 applications were received in May and over 8,000 in the month of June. To Date, Grants.gov has received over 70,000 applications this fiscal year!

Russ Wyland discussed the E-Authentication milestone report. E-Authentication is creating an identity management accreditation within the Federal Government and will be launched in two phases. In the first phase, Federal grantors can log on to E-Authentication on Thursday, August 30. After the implementation of the second phase in August 2007, grant applicants will also be able to utilize this service. Next, the new Grants.gov web design was previewed with a target launch in July. The site will be easier to navigate and use.

Charles Havekost, HHS CIO, then discussed Grant's Management Line of Business. The vision is to deploy a government-wide solution to support end-to-end grants management activities that promote citizen access, customer service and agency financial and technical stewardship.

Dr. Philip Irish III is on a two-month detail from the Department of Defense, where he is a Professor of Information Systems

He is assisting Keenon James as the point of contact for the Department of Defense.

Anne Lopez-Buitrago is on a six month detail with Grants.gov from the National Endowment for the Humanities. At NEH, she serves as a Program Analyst in the Division of Preservation and Access. Anne is currently completing a Bachelor of Arts in Humanities from University of Maryland University College. At Grants.gov, Anne will serve as the Program Manager for DoEd, EPA, NEA, NEH, and NARA.
