Title: State Cemetery Grants

Abstract: The Department of Veterans Affairs (VA) is proposing to amend its regulations governing grants to States to establish, expand, and improve State veterans cemeteries. We propose to implement through regulation new statutory authority to provide grants for the Operation and Maintenance of State veterans cemeteries, as implemented by the Dr. James Allen Veteran Vision Equity Act of 2007 (The Act) (Public Law 110-157), enacted on December 26, 2007. Section 202 of the Act expanded VA authority to provide grants to States for operating and maintaining State veterans cemeteries and limited to \$5 million the amount that VA could award for such grants in any year. The Act required within 180 days of enactment that VA publish regulations on implementing the new authority. VA proposes to amend its regulations to outline the process, the criteria, and the priorities for the award of these Operation and Maintenance grants. The rule also makes changes in arrangement and numbering of the regulation sections and removes specific forms from section 39.26 because all forms cited in this part are available at http://www.cem.va.gov/cem/scg_grants.asp.

Title: Payment and Reimbursement of the Expenses of Medical Services Not Previously Authorized Abstract: The Department of Veterans Affairs (VA) is proposing to amend its regulations concerning emergent hospital care and medical services provided to certain eligible veterans at non-VA facilities that were not preauthorized. Title 38 of the United States Code (U.S.C.) section 1728 authorizes the Secretary to reimburse or make payment for the reasonable value of non-VA emergency treatment that was not preauthorized to veterans who have legal eligibility as stated in 38 U.S.C. section 1728(a). Title 38 Code of Federal Regulations (CFR) further codifies the statute in section 17.120 by defining a medical emergency as an emergency of such nature that delay would have been hazardous to life or health, and in section 17.121 by limiting reimbursement or payment to the period of the initial medical emergency evaluation and treatment. This proposal would amend the regulations to adopt the "prudent layperson" standard for evaluating the need for emergency medical services. This proposal also permits VA to reimburse or pay for hospital care not previously authorized that is furnished beyond the point the medical emergency ended if the veteran requires continued hospital care and requests transfer to VA care but the transfer of the veteran cannot be effected due either to the lack of an available hospital bed at a VA facility or other Federal facility or the inability of VA or other Federal facility to accept transfer of the veteran.

Abstract: The Department of Veterans Affairs is amending its medical regulations that govern the provision of medication to veterans when the medication is prescribed by non-VA physicians. The rule provides that, in limited circumstances, VA may provide medication prescribed by a non-VA physician to veterans enrolled in VA's health-care system prior to July 25, 2003, if the veterans have requested an initial appointment for primary care in a VA health care facility before July 25, 2003, and were unable to obtain an initial appointment for primary care within 30 days. The rule establishes specific requirements that veterans must meet to receive such medication, and it establishes limits on the types and quantities of medication VA may provide. VA's intent is to assist enrolled veterans who have requested primary care appointments but who have not been able to obtain one within 30 days.

Abstract: The Department of Veterans Affairs is amending its education regulations governing the Survivors' and Dependents' Education Assistance (DEA) program to implement statutory provisions in the Veterans Benefits and Health Care Improvement Act of 2000, the Veterans' Survivor Benefits Improvement Act of 2001, the Education and Benefits Expansion Act of 2001, the Veterans Benefits Act of 2002, and the Veterans Benefits Act of 2003. As a result of these statutory provisions certain eligible children may choose the beginning date of their period of eligibility and eligible children who served on active duty or in the National Guard may receive extensions to the ending date of their period of eligibility. Title: Payment or Reimbursement for Emergency Services for Nonservice-Connected Conditions in Non-VA Facilities **Abstract:** The Department of Veterans Affairs (VA) is proposing to amend its regulations concerning emergency hospital care and medical services provided to eligible veterans for nonservice-connected conditions at non-VA facilities. Public Law 106-117 requires VA to pay for the cost of non-VA emergency care for veterans who have no medical insurance and no other means of payment for the care. This is in keeping with Congress' intent, as reflected in House Report No. 106-237, that this reimbursement and payment authority not cover care that is furnished after the patient's condition has been stabilized. This proposal would amend certain regulations to permit VA to pay or reimburse for the costs of continued, non-emergent hospital care furnished to the veteran beyond the point of stabilization if the veteran requires continued hospital care and requests transfer to VA care but the safe transfer of the veteran cannot be effected due either to the lack of an available hospital bed at a VA facility or other Federal facility or the inability of VA or other Federal facility to accept transfer of the veteran.

Title: Release of Information From Department of Veterans Affairs Records

Abstract: This document amends Department of Veterans Affairs (VA) regulations governing the confidentiality and release of VA records subject to the Privacy Act, 5 U.S.C. 552a, the Freedom of Information Act (FOIA) (including the Electronic Freedom of Information Act Amendments of 1996, Pub. L. No. 104-231), 5 U.S.C. 552, and the veterans' records confidentiality statute (section 5701), 38 U.S.C. 5701. This final rule sets forth a mechanism for the public to obtain information from the VA. This final rule is intended to maximize public availability of VA records to the extent permitted by law and considerations such as personal privacy or law enforcement. Essentially these provisions consist of restatements of statute, interpretations of statute, interpretations of case law, interpretations of Executive Orders, and clarification. The final rule amendments also implement the Electronic Freedom of Information Act Amendments of 1996, Public Law No. 104-231 (October 2, 1996), court decisions, and

executive branch guidance issued since the regulations were originally published. Further, this document delegates authority to the Assistant General Counsel for Professional Staff Group IV for making final departmental decisions on appeals under the Freedom of Information Act, the Privacy Act, and 38 U.S.C. 5701 and 5705. This simplifies decisionmaking by allowing the highest level individual with direct responsibility for decisionmaking to issue decisions.
