The subject product is a synthetic organic chemical that is used as an active ingredient in rice herbicide products. It is imported from Japan.

To extend and modify the temporary suspension of duty on Cyhalofop.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CYHALOFOP.**

4 (a) IN GENERAL.—Heading 9902.02.86 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 Propanoic acid, 2-[4-(cyano-2-fluorophenoxy)phenoxy]-
7 butyl ester (2R)) is amended—

8 (1) by striking “1.5%” and inserting “2.0%”;

9 and

10 (2) by striking “12/31/2009” and inserting

11 “12/31/2011”.

1 (b) **EFFECTIVE DATE.**—The amendments made by
2 subsection (a) shall take effect on January 1, 2010.
