**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.

$\beta$ -Bromo- $\beta$ -nitrostyrene (CAS No. 7166-19-0) (provided for in subheading 2904.90.47).

**Product information, including uses/applications and source(s) of imports:**

The subject product, which is imported from Korea, is a microbial growth inhibitor with bacteriostatic and fungistatic properties that effectively control growth of bacteria and fungi in the production of high quality paper, where its biocidal activity and subsequent biodegradability is critically important.

## A BILL

To extend the temporary suspension of duty on  $\beta$ -Bromo- $\beta$ -nitrostyrene.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1.  $\beta$ -BROMO- $\beta$ -NITROSTYRENE.**

4 (a) IN GENERAL.—Heading 9902.32.92 of the Har-  
5 monized Tariff Schedule of the United States (relating to  
6  $\beta$ -Bromo- $\beta$ -nitrostyrene) is amended by striking the date  
7 in the effective period column and inserting “12/31/2011”.

8 (b) EFFECTIVE DATE.—The amendment made by  
9 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
