**Product information, including uses/applications and source(s) of imports:**

The subject synthetic organic chemical is used in the manufacture of specialty coated paper products to allow for the desired printed or written character or image to be imparted or generated on the finished paper/paperboard product. Ciba Specialty Chemicals imports the subject chemical from its affiliated plant in the United Kingdom. This chemical is also available from China.

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. 1-(3H)-ISOBENZOFURANONE, 3,3-BIS(2-METHYL-**  
4 **1-OCTYL-1H-INDOL-3-YL)-.**

5 (a) IN GENERAL.—Heading 9902.24.09 of the Har-  
6 monized Tariff Schedule of the United States (relating to  
7 1-(3H)-Isobenzofuranone, 3,3-bis(2-methyl-1-octyl-1H-  
8 indol-3-yl)-) is amended by striking the date in the effec-  
9 tive period column and inserting “12/31/2011”.

1       (b) **EFFECTIVE DATE.**—The amendment made by  
2 subsection (a) applies to goods entered, or withdrawn from  
3 warehouse for consumption, on or after the 15th day after  
4 the date of the enactment of this Act.
