**Nature of bill:** Extension of temporary duty reduction through December 31, 2011.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

4-Chloro-N-[2-[3-methoxy-4-(2-propynyloxy)phenyl]ethyl]-2-(2-propynyloxy)benzeneacetamide  
(Mandipropamid) (CAS No. 374726-62-2) (provided for in subheading 2924.29.47).

**Product information, including uses/applications and source(s) of imports:**

The subject product is the active ingredient that is used to formulate a fungicide that is used to control late blight in potatoes and downy mildew on a variety of crops. The product is imported from France.

## A BILL

To extend the suspension of duty on NOA 446510 Technical.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. NOA 446510 TECHNICAL.**

4       (a) IN GENERAL.—Heading 9902.12.07 of the Har-  
5       monized Tariff Schedule of the United States (relating to  
6       Mandipropamid) is amended by striking the date in the  
7       effective period column and inserting “12/31/2011”.

8       (b) EFFECTIVE DATE.—The amendment made by  
9       subsection (a) applies with respect to goods entered, or  
10      withdrawn from warehouse for consumption, on or after  
11      the 15th day after the date of the enactment of this Act.
