The subject product is an intermediate that is used in the synthesis of chlorothalonil, which is used to formulate contract fungicides. The product is imported from Japan.

## A BILL

To extend the suspension of duty on (IPN) Isophthalonitrile.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. (IPN) ISOPHTHALONITRILE.**

4       (a) IN GENERAL.—Heading 9902.12.06 of the Har-  
5 monized Tariff Schedule of the United States (relating to  
6 1,3-Benzenedicarbonitrile) is amended by striking the date  
7 in the effective period column and inserting “12/31/2011”.

8       (b) EFFECTIVE DATE.—The amendment made by  
9 subsection (a) applies with respect to goods entered, or  
10 withdrawn from warehouse for consumption, on or after  
11 the 15th day after the date of the enactment of this Act.
