**Nature of bill:** Temporary duty suspension through December 31, 2011.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

Mixtures of N-[2-(2-oxoimidazolidine-1-yl)ethyl]-2-methylacrylamide (CAS No. 3089-19-8), methacrylic acid (CAS No. 79-41-4), aminoethyl ethylene urea (CAS No. 6281-42-1) and hydroquinone (CAS No. 123-31-9) (provided for under subheading 3824.90.92).

**Product information, including uses/applications and source(s) of imports:**

The subject synthetic organic chemical mixture is incorporated in polymer resins to impart surface activity effects, such as better paint adhesion and scrub resistance. The product is imported from France.

5 **ACRYLIC ACID, AMINOETHYL ETHYLENE**  
6 **UREA AND HYDROQUINONE.**

7 (a) IN GENERAL.—Subchapter II of chapter 99 of  
8 the Harmonized Tariff Schedule of the United States is

1 amended by inserting in numerical sequence the following  
 2 new heading:

“ 9902. . . .	Mixtures of N-[2-(2-oxoimidazolidine-1-yl)ethyl]-2-methylacrylamide (CAS No. 3089-19-8), methacrylic acid (CAS No. 79-41-4), aminoethyl ethylene urea (CAS No. 6281-42-1) and hydroquinone (CAS No. 123.31-9) (provided for in subheading 3824.90.9290) ..
