**Product information, including uses/applications and source(s) of imports:**

The subject product is a hindered-amine, light stabilizer that is used as a heat and light stabilizer to improve the dyeability and UV stability of polyamides, polyesters and associated colorants. It is imported from France.

## A BILL

To extend the temporary suspension of duty on 1,3-Benzenedicarboxamide, N, N'-bis-(2,2,6,6-tetramethyl-4-piperidinyl)-.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. 1,3-BENZENEDICARBOXAMIDE, N, N'-BIS-(2,2,6,6-**  
4 **TETRAMETHYL-4-PIPERIDINYL)-.**

5 (a) IN GENERAL.—Heading 9902.04.11 of the Har-  
6 monized Tariff Schedule of the United States (relating to  
7 1,3-Benzenedicarboxamide, N, N'-bis-(2,2,6,6-tetrameth-  
8 yl-4-piperidinyl)-) is amended by striking the date in the  
9 effective period column and inserting “12/31/2011”.

1       (b) EFFECTIVE DATE.—The amendment made by  
2 subsection (a) applies to goods entered, or withdrawn from  
3 warehouse for consumption, on or after the 15th day after  
4 the date of the enactment of this Act.
