**MEMORANDUM ON PROPOSED TARIFF LEGISLATION
of the 110th Congress¹**

Bill No. and sponsor: H.R. 4799 (Mr. Howard Coble of North Carolina).

Proponent name,³ location: Syngenta Crop Protection, Inc., Greensboro, NC.

Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Mixtures of (R)-2-[(2,6-dimethylphenylmethoxy) acetylamino] propionic acid, methyl ester (mefenoxam) (CAS No. 70630-17-0), 4-(2,2-difluoro-1,3-benzodioxol-4-yl)-1H-pyrrole-3-carbonitrile (fludioxonil) (CAS No. 131341-86-1) and 2-cyano-2-methoxyimino-N-(ethylcarbamoyl)acetamide (cymoxanil) (CAS No. 57966-95-7) with application adjuvants (the foregoing mixtures provided for in subheading 3808.92.15).

Product information, including uses/applications and source(s) of imports:

The subject products are synthetic organic chemicals that are used as a seed treatment fungicide for control of diseases such as damping-off and seed rot on peas that are exported. The proponent imports this product from France.

To extend the suspension of duty on mixtures of mefenoxam, fludioxonil, and cymoxanil with application adjuvants.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. MIXTURES OF MEFENOXAM, FLUDIOXONIL,**
4 **AND CYMOXANIL WITH APPLICATION ADJU-**
5 **VANTS.**

6 (a) IN GENERAL.—Heading 9902.02.04 of the Har-
7 monized Tariff Schedule of the United States (relating to
8 mixtures of mefenoxam, fludioxonil, and cymoxanil with
9 application adjuvants) is amended by striking “12/31/
10 2009” and by inserting “12/31/2011”.

1 (b) **EFFECTIVE DATE.**—The amendment made by
2 subsection (a) applies to goods entered, or withdrawn from
3 warehouse for consumption, on or after the 15th day after
4 the date of the enactment of this Act.
