2-Methyl-4-methoxy-6-methylamino-1,3,5-triazine (CAS No. 5248-39-5) (provided for in subheading 2933.69.60).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic intermediate that is used to produce the active ingredients in sulfonylurea herbicides. The resulting postemergence herbicides are used for selective grass and weed control in cereal crops. The subject product is imported from China.

## A BILL

To extend the temporary suspension of duty on 2-Methyl-4-methoxy-6-methylamino-1,3,5-triazine.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. 2-METHYL-4-METHOXY-6-METHYLAMINO-1,3,5-**  
4 **TRIAZINE.**

5 (a) IN GENERAL.—Heading 9902.13.44 of the Har-  
6 monized Tariff Schedule of the United States (relating to  
7 2-Methyl-4-methoxy-6-methylamino-1,3,5-triazine) is  
8 amended by striking “12/31/2009” and inserting “12/31/  
9 2011”.

1       (b) EFFECTIVE DATE.—The amendment made by  
2 subsection (a) applies to goods entered, or withdrawn from  
3 warehouse for consumption, on or after the 15th day after  
4 the date of the enactment of this Act.
