MEMORANDUM ON PROPOSED TARIFF LEGISLATION of the 110th Congress ¹

Bill No. and sponsor: H.R. 5197 (Ms. Ellen O. Tauscher of California).

Proponent name, location: Applied Materials, Inc., Santa Clara, CA.

Other bills on product (110th Congress only): None.

Nature of bill: Temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Mounting flanges of plastics, having an interior diameter of 286 mm and a wall thickness of 45 mm, the foregoing classifiable as parts of machines used to fabricate semiconductor chips, integrated circuits, liquid crystal displays or solar cells (provided for in subheading 8543.90.88).

Product information, including uses/applications and source(s) of imports:

According to the proponent, the subject product is a plastic mounting flange that is attached to equipment used to fabricate semiconductor chips or integrated circuits, liquid crystal displays, and/or solar cells. Once mounted on the machine, the flange provides support for the integration or support of another component on the machine. Such a part may be produced by contract manufacturers of plastic parts. The principal U.S. import sources of these flanges are reported to be Germany and Taiwan. Dutiable U.S. imports of all products under HTS subheading 8543.90.88 (a broader category than is covered by this bill) totaled \$307 million in 2007, of which \$68.7 million came from Germany, the leading importer, and \$23.8 million came from Taiwan, the fourth leading importer.

Technical comments:4

Little specific information about the product in question has been supplied by the proponent, and it is therefore difficult to draft appropriate language for a tariff heading. The bill as drafted describes the product as "White," a type of criterion that is not normally used in tariff descriptions, lacks definition, and does not really help delineate the product intended to be covered in a useful manner. Accordingly, it has been removed from the suggested article description in order to be consistent with normal drafting practice. We have suggested other changes, as shown on page 1, without being able to ascertain from the proponent the nature of the product in question. Customs may nonetheless have difficulty administering this provision because the physical dimensions of the part are very specific and thus may be burdensome; because not every product of the type named may have exactly the specified dimensions, some goods of interest to the proponent may be excluded.

It is not possible to verify the classification of the product in the HTS, based on available information. In addition, a flange that the importer believes to be described as a machine part cannot necessarily be identified by Customs officials at the port as being dedicated to use as a machine part, by virtue of its physical characteristics, rather than being classified as an article of plastics. Similarly, the type or types of machines with which a particular flange might be used (when that flange is separately imported) might not be possible to verify at the time of entry. Commission staff has been unable to obtain sufficient information from the proponent to suggest appropriate amendments to remedy these problems.

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
